## NARELLAN VARIATION OF TRUSTS ORDINANCE 1986

# NO. 1, 1986

AN ORDINANCE to vary the trusts of certain land at Narellan and matters incidental thereto

## WHEREAS

- A. Anglican Church Property Trust Diocese of Sydney (hereinafter called the "Corporate Trustee") is the registered proprietor of the whole of the land comprised in Certificate of Title Volume 309% Folio 193 more particularly described in the First Schedule hereto.
  - B. The land in the First Schedule is church trust property within the meaning of the Anglican Church of Australia Trust Property Act, 1917 (as amended) held upon trust to permit the same to be used for an extension to St. Paul's Cobbitty burial ground.
  - C. The Corporate Trustee is the registered proprietor of the whole of the land comprised in Certificate of Title Volume 5102 Folio 36 more particularly described in the Second Schedule hereto.
  - D. The land in the Second Schedule is church trust property within the meaning of the Anglican Church of Australia Trust Property Act, 1917 (as amended) held upon trust to permit the same to be used for the benefit of St. Paul's Church of England Cobbitty.
  - E. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the land in the First and Second Schedules is held it is inexpedient to carry out and observe the same to the extent to which the same are hereby varied.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:

- 1. By reason of the circumstances which have arisen subsequent to the creation of the trusts upon which the land described in the First and Second Schedules hereto is held, it is inexpedient to carry out and observe the same and it is expedient that such trusts be varied as hereinafter set out.
- 2. The land described in the First and Second Schedules shall henceforth be held upon trust for a hall or halls in connection with the Anglican Church of Australia within the Diocese of Sydney for the sole benefit of the Parish of Narellan or any parish or ecclesiastical district into which it may subsequently be formed or form a part.
- This ordinance may be cited as the "Narellan Variation of Trusts Ordinance 1986".

# FIRST SCHEDULE

ALL THAT piece or parcel of land at Cobbitty in the Municipality of Camden Parish of Narellan and County of Camden being the land in Certificate of Title Volume 3098 Folio 193.

## SECOND SCHEDULE

ALL THAT piece or parcel of land similarly situated being the unnumbered lot in Deposited Plan 81585 and the land in Certificate of Title Volume 5102 Folio 36.
