NEW SITES ORDINANCE 1982 AMENDING ORDINANCE 1985

NO. / 1985

AN ORDINANCE to amend the New Sites Ordinance 1982

WHEREAS

- A. The New Sites Ordinance 1982 provides (inter alia) that the sum of one million dollars (\$1,000,000) be applied in acquiring "approved land" as defined therein.
- B. An appeal, now called "Vision for Growth" is being made to raise money to permit (inter alia) land and/or buildings to be acquired or constructed within the Diocese.
- C. It is expedient that provision be made for the regulation of the expenditure of part of the money raised.

NOW the Standing Committee of the Synod of the Diocese of Sydney
in the name and place of the said Synod HEREBY ORDAINS DECLARES
DIRECTS AND RULES as follows:-

- 1. (1) This Ordinance may be cited as the "New Sites Ordinance 1982 Amending Ordinance 1985".
- (2) The New Sites Ordinance 1982 is hereinafter called the "Principal Ordinance".
- (3) The Principal Ordinance as amended by this Ordinance may be cited as "New Sites Ordinance 1982-1985" and clause 7 thereof is amended accordingly.
- 2. The Principal Ordinance is amended by the insertion of "or clause 3A" at the end of clause 1 (2) and by the insertion of the following clause after clause 3.
 - "3A (1) This clause shall apply to all moneys obtained by the Property Trust or vested in it to be applied pursuant to this Ordinance other than the said sum of one million dollars (\$1,000,000).

- (2) Subject to the following sub-clauses of this clause, the Property Trust shall invest all moneys to which this clause applies in acquiring approved land.
- (3) Rending the acquisition of approved land, the moneys to which this clause applies may be invested by the Property Trust in any mode of investment which the Property Trust is authorised to make.
- (4) No land acquired pursuant to this clause shall be Church trust property but shall not be held (or be deemed to be held) in trust for the sole benefit of any parish or other ecclesiastical district in the Diocese.
- (5) The Property Trust shall not sell any land acquired pursuant to this clause except pursuant to an ordinance made pursuant to Section 26 of the Anglican Church of Australia Trust Property Act, 1917. Clauses 11, 12, 13, and 16 of the Delegation of Powers and Ordinance Procedure Ordinance 1973-1977 (hereinafter called the "Delegation Ordinance") shall apply in relation to each application for any such ordinance except that the notice to be given pursuant to clause 13 of the Delegation Ordinance shall be given in the parish (as defined in that Ordinance) in which the land may then be If any objection is made pursuant to clause 16 of the Delegation Ordinance to a proposed ordinance the Standing Committee may refer but shall not be obliged to refer the proposed ordinance to a committee appointed or constituted pursuant to clauses 18, 19 or 20 of the Delegation Ordinance.
- (6) Sub-clauses (3) and (10) of clause 3 shall apply to moneys to which this clause applies and land acquired pursuant to this clause."
