Proposal to change the status of the provisional parish of North Ryde to a parish

(A report from the Northern Regional Council.)

Proposal

1. A proposal was made to the Archbishop by the minister and wardens of the provisional parish of St John's, North Ryde under clause 4 of the Parishes Ordinance 1979 for reclassification as a parish.

Details of meeting

- 2. A meeting of the Northern Regional Council held on 19 August 2009 considered the proposal under clause 5 of the Parishes Ordinance.
- 3. The Northern Regional Council certifies that all procedural requirements under clauses 4 and 6 of the Parishes Ordinance have been completed, and recommends that the Synod raise the status of the provisional parish to a parish.

Parish information

- 4. The first branch church of St Anne's Ryde was St John's North Ryde which commenced in 1879. In it became a provisional district in 1962 and a provisional parish in 1967, achieving full parish status in 1973. However, in 1998 the parish reverted to provisional status. With the appointment of the Rev. John Chappell in 2007, the church has become refocussed and re-energised with increased attendance enabling the offertories to rise above the threshold for regaining full parish status. Furthermore, the parish has been able to appoint a Senior Assistant Minister, the Rev Peter Hughes, who began a church plant in East Ryde in 2009.
- 5. In the current year, regular attendance at St John's is as follows -
