Proposal to change the Parish of North Ryde to a Provisional Parish

(A report from the North Sydney Regional Council.)

Initiation of Proposal

1. A proposal was made to the Archbishop by the Minister and Churchwardens of St. John's North Ryde under clause 4(1)(c) of the *Parishes Ordinance 1974*.

Details of Meeting

- 2. A meeting of North Sydney Regional Council was held on 17 June 1997 to consider the proposal under clause 5 of the Ordinance.
- 3. North Sydney Regional Council certified that all procedural requirements under clauses 4 and 6 have been complied with and noted that no objections had been received.

Proposal

- 4. The proposal is to change the parish to a provisional parish.
- 5. The parish has been unable to meet the local revenue threshold in the years 1993, 1994, 1995 and 1996. The parish was not automatically reclassified because Standing Committee, at the request of the Churchwardens, resolved that clause 8 of the Ordinance (which deals with automatic reclassification) should not apply in relation to the 1993 year. With the rise in parish recovery costs, the parish could not see the threshold being met in the immediate future and so the Minister and Churchwardens made the proposal in this report. There are no arrears of assessments.

Parish Information

- 6. St John's North Ryde is a relatively small area but one that has many characteristics of village life with a well-defined community. There is a strong core of committed members and a well-run parish preschool, which offers ongoing contact with families. There are approximately 4,600 persons claiming adherence to the Anglican Church of Australia within the parish. Some long standing members of the parish have moved out as a result of retirement.
- 7. The parish has never failed to meet the minister's stipend or Synod assessments. The congregation is stable after a change of ministry at the end of 1995. New initiatives are being taken and new families contacted.
- 8. The Rector also serves as a part-time Chaplain at Macquarie University, for which Synod funding is made available.
- 9. There are approximately 100 adults and 20 children who would be considered to be members of the congregation. Special services held from time to time attract additional people. The main point of growth is the morning congregation. The parish has members from a number of cultures.
