

# Parochial Cost Recoveries and Church Land Acquisitions Levy Ordinance 2013 Further Amendment Ordinance 2014

No 25, 2014

## Long Title

An Ordinance to amend the Parochial Cost Recoveries and Church Land Acquisitions Levy Ordinance 2013.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

### 1. Name

This Ordinance is the Parochial Cost Recoveries and Church Land Acquisitions Levy Ordinance 2013 Further Amendment Ordinance 2014.

### 2. Amendment of the Parochial Cost Recoveries and Church Land Acquisitions Levy Ordinance 2013

The Parochial Cost Recoveries and Church Land Acquisitions Levy Ordinance 2013 is amended as follows –

- (a) omit the Long Title and insert instead the following –

#### **“Long Title**

An ordinance to determine the cost recoveries charge and levy for the acquisition of land for church sites payable by parochial units in 2014 and 2015, to authorise the application of such charges and for incidental purposes.”, and

- (b) insert the following words at the end of paragraph A of the Preamble –  
“, provided that in 2014 and 2015 St Andrew’s Cathedral is only required to pay a cost recoveries charge in respect of ministry costs.”,  
and
- (c) insert the matter “and 2015” after the matter “2014” in paragraph B of the Preamble, and
- (d) omit the matter “, and indicates the Synod’s intention for the amounts to be paid and applied in 2015” in paragraph B of the Preamble and insert instead “.”, and
- (e) insert the matter “and 2015” after the words “In 2014” in clause 3(1), and
- (f) omit clause 3(3) and insert instead the following –  
“(3) The Standing Committee is to report to the first ordinary session of the 50<sup>th</sup> Synod about –  
(a) the ministry costs and parochial network costs payable in 2015 and an estimate of the amounts payable, and  
(b) the cost recoveries charge estimated to be payable by each parochial unit in 2015 and details of how that charge is calculated.”, and
- (g) omit the matter “For 2015 the Standing Committee is to pass all such ordinances as may be necessary, from time to time, to give effect to the Synod’s intention that” in clause 4(2) and insert instead “In 2015”, and
- (h) insert the words “is to” in clause 4(2) after the words “except St Andrew’s Cathedral.”, and
- (i) omit the number “2014” in clause 4(3), and
- (j) omit the matter “subclause (1)” in clause 4(4) and insert instead “this clause”, and
- (k) omit the number “2014” in the Schedule clause 1 and insert instead “a year”, and
- (l) omit clause (b) of the definition of “minister and assistant minister charge” in clause 2 of the Schedule and insert instead the following –

- “(b) the costs of the contribution required to the Sydney Long Service Leave Fund in order to enable that Fund to make the payment or payments required to be made under –
  - (i) the Long Service Leave Canon 1992 in 2014, and
  - (ii) the Long Service Leave Canon 2010 in 2015, and”, and
- (m) omit the definition of “variable charge” in clause 2 of the Schedule and insert instead the following –
  - “variable charge means –
    - (a) in 2014 – the determined percentage for that year of the Net Operating Receipts of the parochial unit for 2012 under the Framework Ordinance, and
    - (b) in 2015 – the determined percentage for that year of the Net Operating Receipts of the parochial unit for 2013 under the Framework Ordinance.”, and
- (n) insert the matter “or 2015 as applicable” after the matter “2014” in the definition of “determined percentage” in clause 2 of the Schedule, and
- (o) insert the matter “or 2013 respectively” at the end of the definition of “determined percentage” in clause 2 of the Schedule.
