## Parramatta Anglican Regional Council Constitution Amendment Ordinance 1984

- are summoned or appointed under the 14th of the Constitutions contained in the Schedule to the Anglican Church of Australia Constitutions Act, 1902, and are resident within the region.
- A person so elected shall remain a member of the Council until the next election of members unless he resigns or ceases to qualify or is declared by any competent court to be bankrupt or incapable of managing his affairs, and shall, if otherwise qualified, be eligible
  - for re-election. 10 Casual vacancies under paragraph (v) of clause % of this Ordinance shall be filled from time to time by the Council, Persons so appointed shall hold office intil the next ordinary session of Synod when a by-election shall be held.
    - 15 If an elected member of the Council shall be absent from three successive meetings of the Council without the permission of the Council he shall thereupon ceases to hold office and a casual vacancy shall be created."
- The Principal Ordinance is amended by omitting paragraph (e) 25 of clause 11 and by inserting instead the following paragraph to appoint committees of the Council to act on its behalf in connection with paragraphs (a), (b), (c) and (d) "(e) (l) of this clause. to appoint committees including, if desired, persons 30 other than members of the Council, to perform such lasks as are given them by the Council. Such committees shall be directly responsible to the Council."

(3) The first election under the amendments effected by this clause shall be held at the ordinary session of Synod in 1985 and the present members of the Council shall continue in office until
