Presentation and Exchange Ordinance 1933-1959 (Amendment) Ordinance 1961.

No. 41, 1961.

An Ordinance to amend the Presentation and Exchange Ordinance 1933-1959.

Whereas Section 8 of the Presentation and Exchange Ordinance 1933-1959 as amended provides that a Parish shall have the right to elect representatives under that Ordinance for the purpose therein set out only if the conditions of such Section have been fulfilled AND WHEREAS it is desirable to amend certain of such conditions the Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the Church of England within the State of New South Wales and of all other powers vested in it ORDAINS AND RULES as follows:-

- 1. The Presentation and Exchange Ordinance 1933-1959 is in this Ordinance referred to as "the Principal Ordinance."
- 2. The Principal Ordinance as amended by this Ordinance may be cited as "Presentation and Exchange Ordinance 1933-1961."
 - 3. The Principal Ordinance is amended as follows:-

By deleting sub-paragraph (1) of paragraph (a) of sub-clause 1 and inserting in its place the following sub-paragraph:-

"A stipend of at least the amount last recommended by resolution of Synod as the minimum stipend payable to a Rector from local sources during the financial year in respect of which such recommendation shall be effective."

4. The Principal Ordinance is amended further by inserting the following proviso at the end of Clause 8 sub-clause 1 paragraph (d):
"Provided that in favour of a Parish which has complied with the provisions of Clause 14 (2) (kk) of the General Assessment Authorisation Ordinance 1959-1961 and also in the case where all arrears outstanding by any Parish under the powers conferred on Standing Committee by Clause 15 of such Ordinance in respect of assessments made by or in pursuance of the Ordinances referred to and numbered (i) and (viii) in such clause this sub-clause shall be deemed to have been fulfilled so far as it applies to the payment of arrears required thereby."

- 5. The Principal Ordinance is amended further by inserting the following new paragraph in Clause 8 sub-clause 1:-
 - "(f) The payment to the Sydney Diocesan Superannuation Fund of the proportion payable by the Parish, including any arrears, required to be paid as part of the contribution to that Fund under the provisions of the "Sydney Diocesan Superannuation Fund Ordinance 1961" or any ordinance amending or taking the place of the same."
- 6. Paragraph (b) of clause 9 of the Principal Ordinance is amended by inserting after the words "elected by" the following words: "the adult parishioners present at."
