The Presentation and Exchange Ordinance Amending Ordinance 1955.

AN ORDINANCE to amend further "The Presentation and Exchange Ordinance, 1933-54."

WHEREAS it is expedient to amend further "The Presentation and Exchange Ordinance 1933-54."

Now the Synod of the Diocese of Sydney hereby ordains directs and rules as follows:---

1. This Ordinance may be cited as "The Presentation and Exchange Ordinance Amending Ordinance 1955."

- (a) "The Presentation and Exchange Ordinance 1933" as amended by subsequent Ordinances is in this Ordinance referred to as the Principal Ordinance.
 - (b) The Principal Ordinance as amended by this Ordinance may be cited as "The Presentation and Exchange Ordinance 1933-55."
- 3. The Principal Ordinance is amended as follows:-
 - (a) By deleting the figures "600" from sub-paragraph
 (1) of paragraph (a) of sub-clause 1 of Clause 8 and inserting in lieu thereof the figures "750."
 - (b) By inserting the words "The free use of" at the beginning of sub-paragraph (2) of the said paragraph (a), and by omitting the words "or full rent in lieu thereof."
 - (c) By omitting the words "rent (if no residence)" from paragraph (b) of sub-clause 1 of Clause 8.
 - (d) By omitting paragraph (c) of the said sub-clause 1 of Clause 8.

- (e) By omitting the words "1(c) and" after the word "Sub-clauses" in the 13th line of Clause 8, Sub-clause 2, paragraph (a), and by adding the words "and 1 (e)" after the number "1(d)."
- (f) By omitting the words "this Sub-clause" in paragraph (b) of the said Sub-clause 2 of Clause 8 and inserting after the word "of" in the third line the words "Sub-clauses 1 and 2 of this Clause."
- (g) By omitting the words "this Sub-clause" in paragraph (c) of the said Sub-clause 2 of Clause 8 and inserting after the word "of" in the second line the words "Sub-clauses 1 and 2 of this Clause."
- (h) By inserting after the word "respecting" in Subclause 3 of Clause 8 the words "the condition of the residence and."

4. Sub-clauses (a) (b) and (h) of Clause 3 of this Ordinance shall not take effect until after 31st March, 1956.
