Covid-19 advice for the Diocese

Changes to the Residential Tenancy Act

If your parish rents or is a tenant in a house or apartment you will need to be aware of changes to the Residential Tenancy Act that came in on 23 March. These changes cover the following areas:

- New minimum standards that define what 'fit for habitation' means
- An obligation that smoke alarms are in working order
- A list of minor alterations that a landlord cannot withhold consent for (with the tenant required to remove modifications at the end of their tenancy)
- Mandatory break fees for fixed term agreements, reducing depending on the remaining duration of the lease
- Information disclosure obligations on the landlord
- Water efficiency measures
- New rectification order processes for both landlords and tenants

Community Building Partnerships

We are really pleased to be able to let you know that 75 parish applications for projects have been successful. Those parishes will receive grant funding totalling \$1,505,863 under the CBP 2019-2020 program. The grants ranged from \$2,500 to \$82,759 with an average of \$20,000 and included: air conditioning, CCTV, children's playgrounds, refurbishment of church halls, bathrooms and kitchens, roof repairs, shade structures, solar panels and synthetic grass.

Applications for the 2020-2021 CBP grant round will be open from 4 May 2020 to 12 June 2020. We will provide a parish portal circular to parishes on how to apply at that time. In the meantime your parish may wish to consider which property projects will be suitable for a CBP grant.

Annual Fire Safety Statements

Some parishes are required to complete an annual fire safety statement and return it to their local council. In the past this statement has needed to be forwarded to the PPS team for an owner's signature before submission. From the end of the February 2020 the new form no longer requires an owner's signature so can now be completed by a warden as the owner's agent.
