

Robertson (Kangaloon and Glenquarry) Land Sale Ordinance 1993 Amendment Ordinance 1997

No 11, 1997

Long Title

An Ordinance to amend the Robertson (Kangaloon and Glenquarry) Land Sale Ordinance 1993.

Preamble

- A. Certain funds (the "Funds") are church trust property held on the trusts specified in the Robertson (Kangaloon and Glenquarry) Land Sale Ordinance 1993 (the "Principal Ordinance").
- B. By reason of circumstances arising after the creation of the trusts on which the Funds are held it is inexpedient to carry out and observe those trusts and it is expedient that those trusts be varied in the manner set out in this ordinance.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows -

Name of Ordinance

1. This Ordinance is the Robertson (Kangaloon and Glenquarry) Land Sale Ordinance 1993 Amendment Ordinance 1997.

Declarations of Inexpediency

2. By reason of circumstances arising after the creation of the trusts on which the Funds are held it is inexpedient to carry out and observe those trusts and it is inexpedient that the Funds be applied for the same or like purposes as the trusts on which they are presently held.

Amendment of the Principal Ordinance

- 3. Clause 5 of the Principal Ordinance is deleted and the following is inserted instead -
- "5. Pending application of the proceeds of sale under clause 4, the proceeds must be invested and the income applied as follows -
- (a) an amount equal to 25% of the income is to be paid to the churchwardens of St John's Church, Robertson to be applied by them for such purposes of the Parish as are determined from time to time by the parish council, other than the payment of the stipend, allowances and benefits of the minister;
- (b) an amount equal to 25% of the income is to be applied toward assessments and arrears of assessments owed by the Parish from time to time; and
- (c) the balance of the income must be capitalised."
- 4. After clause 5 of the Principal Ordinance the following new clause is inserted -
- "6. The authority to apply the remaining proceeds of sale under clause 4 and the authority to apply the income under clause 5 each terminate on 30 June 2002. The churchwardens of St John's Robertson must, by 31 March 2002, promote a further ordinance to provide for the application after 30 June 2002 of the remaining proceeds of sale and the income."

Application of Amendments

5. The amendments to the Principal Ordinance made by clauses 3 and 4 of this Ordinance apply only in relation to income earned on and from 1 January 1997. Any income earned prior to that date which has not been applied on the date on which this Ordinance receives assent is to be applied in the manner it would have been applied under the Principal Ordinance had this Ordinance not been passed and received assent.
