# Rosemeadow (Picton Boundary Alteration) Variation of Trusts Ordinance 2018

No 39, 2018

## Long Title

An Ordinance to vary the trusts of certain land currently comprising part of the capital of the ACPT – Rosemeadow Trust.

### Preamble

A. Anglican Church Property Trust Diocese of Sydney (the "ACPT") is the trustee of the land in folio identifiers 4/1/759094, 7/1/759094, and 1/1236516 known as Wilton Anglican Church and Cemetery (the "Land") and is held for the purposes set out in clause 5 of the Rosemeadow Trust Ordinance 2001.

B. The ACPT is also the trustee of the property in the Picton Trust, held for the purposes of the Parish of Picton on the terms set out in the Picton Trust Ordinance 2004.

C. By reason of circumstances which have arisen after the creation of the trusts on which the Land is held, it is inexpedient to carry out and observe those trusts or to apply the Land wholly for the purposes of the Parish of Rosemeadow and it is expedient that the trusts of the Land be varied in the manner set out in this Ordinance.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

#### 1. Name of this ordinance

This Ordinance is the Rosemeadow (Picton Boundary Alteration) Variation of Trusts Ordinance 2018.

#### 2. Declarations

By reason of circumstances which have arisen after the creation of the trusts on which the Land is held, it is inexpedient to carry out and observe those trust or to apply the Land wholly for the purposes of the Parish of Rosemeadow and it is expedient that the trusts be varied in the manner set out in clause 3.

#### 3. Variation of trusts

The trusts of the Land are varied so that it is henceforth held on trust for the purposes of the Parish of Picton as part of the capital of the ACPT-Picton Trust held under the Picton Trust Ordinance 2004.

#### 4. Amendment to the Rosemeadow Trust Ordinance 2001

The Rosemeadow Trust Ordinance 2001 is amended by -

(a) deleting the following matter from the table in the Schedule –
