

Ryde Trust Ordinance 2013 Amendment Ordinance 2022

No 50, 2022

Long Title

An Ordinance to amend the *Ryde Trust Ordinance 2013*.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name

This Ordinance is the Ryde Trust Ordinance 2013 Amendment Ordinance 2022.

2. Amendment

The *Ryde Trust Ordinance 2013* is amended as follows –

- (a) in clause 3 delete the definition of “2 Little Church Street Land” in its entirety,
- (b) in the title of clause 10 –
 - (i) delete the comma following the words “Kirkby Gardens” and insert instead the word “and”,
 - (ii) delete the matter “and 2 Little Church Street”,
- (c) delete the matter in subclause 10(1)(c) in its entirety and consequently renumber the existing clauses,
- (d) in the renumbered subclause 10(1)(d) delete the word “and”,
- (e) insert a new subclause 10(1)(e) as follows –

“(e) Heritage Fund, and”
- (f) in clause 10(4) –
 - (i) delete the comma following the matter “Kirkby Gardens Land” and insert instead the word “and”,
 - (ii) delete the matter “and the 2 Little Church Street Land”,
- (g) in subclause 10(5)(b) substitute the matter “50,000” for “40,000”,
- (h) in subclause 10(5)(c) –
 - (i) substitute the matter “125,000” for “110,000” and delete the word “and”,
 - (ii) insert a new subclause 10(5)(d) as follows and consequently renumber the existing clauses –

“(d) fourthly, the payment of \$50,000 per annum to the Heritage Fund,”
- (i) in the renumbered clause 10(5)(e) substitute the word “fifthly” for “fourthly”,
- (j) in clause 10(6) –
 - (i) delete the matter “, and” following the matter “10(5)(a), (b)”,
 - (ii) insert the matter “, and (d)” following the matter “(b), (c)”,
 - (iii) substitute the matter “10(5)(e)” for the matter “10(5)(d)” following the matter “in accordance with clause”,
- (k) in clause 10(7) –
 - (i) delete the comma following the matter “Kirkby Gardens Land” and insert instead the word “and”,
 - (ii) delete the matter “and the 2 Little Church Street Land”, and
- (l) insert a new clause 10(9) as follows –

“(9) The Heritage Fund is to be applied for the preparation and implementation of a suitable Heritage Management Plan and for the preservation, repair, renovation and maintenance of –

 - (a) the church building located on the land contained in folio identifier Auto Consol 6626-202 known as St Anne’s Church and 42-50 Church Street, Ryde (“St Anne’s Church”),
 - (b) headstones and other memorials and items in the St Anne’s Church graveyard,
 - (c) the former Ryde Court House contained in folio identifier Auto Consol 6626-202 known as 42 Church Street, Ryde,

- (d) furniture, equipment and other items, including records of historical interest contained in the real property forming part of the ACPT – Ryde Trust, and
- (e) similar historically significant purposes as determined by the Parish Council from time to time.”

3. Commencement

This Ordinance commences on 31 December 2022.
