1.6 Microphones are conveniently placed throughout the Theatre. If you are called to speak in debate move to the nearest microphone and speak into it. Don't get too close to or speak across the microphone.

Synod Procedures: What You Must Know

1.9 You should read the business rules contained in the Schedule to the Conduct of the Business of Synod Ordinance 2000. A copy of that ordinance is found on pages 164 to 183 of *Acts, Ordinances & Regulations* which is circulated with this circular. Further information is contained in the paper entitled "Synod Procedures" which can be found on the Synod's website at www.sydney.anglican.asn.au/synod/dioadmin/synodprocedure.htm. 1.10 Printed material which has not been tabled in the Synod, or which has not been authorised by the Synod, must not be placed on tables or handed out in the Theatre or inside the entrance to the Theatre. Copies of the material which has been tabled may be circulated at a convenient time by arrangement with the Diocesan Secretary.

1.11 Forms for motions, amendments and questions are available from the Secretaries' Table, the Clerks' Table or the Diocesan Secretary's office on the Second Floor of St Andrew's House. Guidelines for the moving of motions were printed in items 2.11 to 2.14 of the first Circular to Synod members dated 6 August 2002.

1.12 Notices of further motions and notices of questions may be given at the start of proceedings on 14, 15 and 16 October, but not on 21 and 22 October without leave of the majority of the members present. Questions are usually answered the day after notice has been given. If you want to give notice of a question please read the appropriate section in the paper on "Synod Procedures" and make sure the wording of the question complies with Business Rule 6.3.

1.13 There is a question time on a bill for an ordinance after the motion that a bill be approved in principle has been moved and seconded. Questions may be asked without notice at this time, but speeches and statements are not allowed. It is in the interests of the whole Synod if the mover of a bill (or one of the Secretaries) is notified in advance of any questions so that, if necessary, answers can be researched.

1.14 To move an amendment during a debate, you must catch the attention of the President (the Chairman of Committees when the Synod is in committee), state that you wish to move an amendment, read the amendment and speak to it. If you have not already handed in the text at the Secretaries' Table, one of the clerks will collect it from you after you have spoken.

1.15 You don't need to give formal notice of an amendment. But it would be appreciated if members wishing to move amendments would give details to one of the Secretaries as early as possible. If there is time, the movers will be told, the amendments will be printed for the Synod and perhaps different points of view can be reconciled without taking up valuable time of the whole Synod.

2. Meals and car parking

Meals etc

2.1 Drinking water dispensers are located in the Theatre Foyer. *Consumption of food and beverages in the Theatre* is not permitted.

2.2 There are a number of small restaurants and cafes in the vicinity of the Wesley Centre and the Sydney Town Hall where a quick cup of coffee or a meal can be obtained for a reasonable range of prices.

Car Parking

2.3 We have negotiated car parking rates at 2 parking stations. The procedure is the same in both car parks: take a ticket from a machine as you enter, get a voucher from the Clerks' Table in the Wesley Theatre, and hand the voucher in when you present your ticket for payment. You need a voucher for each day.

Half Day Rate (in between 1 pm and 5 pm out before midnight) \$9

Evening Rate (in after 5 pm out before midnight) \$7

Piccadilly Car Park

Full Day Rate (in before 2 pm out before 10:30 pm) \$45

Half Day Rate (in after 2 pm out before 10:30 pm) \$10

2.4 We cannot guarantee parking in either of these car parks but if they are full there are other car parks you might use (in Kent Street especially). Overnight parking costs extra.

3. Elections for this Synod Session

3.1 Under clause 5.2 of the Synod Elections Ordinance 2000, a list of the Contested Elections to be conducted at this Synod session is attached at item 5, showing the persons nominated, their occupations and addresses, the names of the nominators and the positions for which they are nominated.

3.2 The Returning Officer (Martin Thearle) and the Deputy Returning Officer (Andrew Sillar) will be situated in the Theatre Foyer.

3.3 The ballot will commence at 2.00 pm on Monday 14 October and close at 9 pm on Tuesday 15 October. Ballot papers will be issued between 2 pm and 8 pm on those days. The ballot box will be open from 2 pm to 9 pm on both days.

3.4 It would help the Returning Officers if members would avoid a last-minute rush by casting their votes early.

3.5 The list of Uncontested Elections will be tabled in the Synod on 14 October.

4. Election of Standing Committee Members by the Whole Synod

4.1 Under the Standing Committee Ordinance 1897, 4 qualified ministers and 8 qualified laypersons are to be elected as members of the Standing Committee by the whole Synod before the Synod session.

4.2 Nominations for this election closed at 5:00 pm on 2 September 2002.
