Nomination (Transitional Provisions) Ordinance 2006

No 34, 2006

Long Title

An Ordinance to make provision for transitional arrangements for the Nomination Ordinance 2006.

The Synod of the Diocese of Sydney Ordains as follows.

1. Name of Ordinance

This Ordinance is the Nomination (Transitional Provisions) Ordinance 2006.

2. Amendments

- (1) The Parishes Ordinance 1979 is amended by omitting clause 6(b) and inserting instead the following -
 - "(b) during the financial year before the date on which the proposal is received by the Standing Committee, or such part of that financial year as a member of the clergy was licensed as minister, the minister was -
 - paid or provided with a stipend or benefits in lieu of stipend the amount or value of which, in total, was not less than that part of the minimum stipend referred to in clause 6(a)(i) which was required to be paid or provided to the minister, and
 - (ii) paid or provided with a travel allowance or travel benefit not less than that part of the fixed component of the travel allowance referred to in clause 6(a)(ii) which was required to be paid or provided to the minister, and
 - (iii) provided with the free use of a residence or otherwise housed in accommodation approved as suitable by the Archbishop.".
- (2) The Church Administration Ordinance 1990 is amended as follows $\,$
 - (a) omit "parish representatives elected or appointed under the Presentation and Exchange Ordinance 1988" in the definition of "parish office holder" in clause 2(1) and insert instead "parish nominators elected or appointed under the Nomination Ordinance 2006", and

- (b) omit "to elect parish representatives if entitled to do so in accordance with the Presentation and Exchange Ordinance 1988" in clause 11(1) and insert instead "to elect parish nominators if entitled to do so in accordance with the Nomination Ordinance 2006".
- (3) The Schedule to the Parishes (Special Administration) Ordinance 2004 is amended by omitting clause 8(2)(a) and inserting instead the following
 - "(a) parish nominators to be elected for the parish under the Nomination Ordinance 2006 and parish representatives to be elected under the Synod Membership Ordinance 1995 are to be elected at the annual parish meeting or other parish meeting, and".

3. Repeal

The Presentation and Exchange Ordinance 1988 is repealed.

4. Savings and transitional provisions

- (1) The provisions of the Nomination Ordinance 2006 and clauses 2 and 3 of this Ordinance do not apply to a vacancy occurring in the office of rector of a parish before the date on which the Nomination Ordinance 2006 commences. The provisions of the Presentation and Exchange Ordinance 1988 apply to such a vacancy as if the Nomination Ordinance 2006 had not been made.
- (2) The repeal of the Presentation and Exchange Ordinance 1988 does not affect or invalidate any act done under that Ordinance.
- (3) All persons elected or appointed under the Presentation and Exchange Ordinance 1988 and holding office immediately before the repeal of that Ordinance are to remain in office as if they had been elected or appointed under the Nomination Ordinance 2006.

5. Commencement

- (1) Subject to subclause (2), this Ordinance commences on the date of assent.
- (2) Clauses 2, 3 and 4 commence on the date assent is given to the Nomination Ordinance 2006.
