Proposal to change the status of the Provisional Parish of Harbord to a Parish

(A report from the North Sydney Regional Council.)

Initiation of proposal

1. A proposal was made by the Churchwardens of St Mark's Church Harbord under clause 4(1)(c)(iii) of the Parishes Ordinance 1979 (the "Ordinance").

Details of Meeting

2. A meeting of the Parish Investigation Committee on 18 July 2001 considered the proposal under clause 5 of the Ordinance. Regional Council by postal vote, accepted the recommendation and endorsed the proposal.

3. All the procedural requirements under clause 4 of the Ordinance have been satisfied.

Proposal

4. The proposal is to change the Provisional Parish of Harbord to a full parish.

5. As a Provisional Parish, St Mark's has been blessed with the work that God has been doing in their midst and through the ministry of Mark Dickens, with the result that church attendances have grown and parish finances have returned to a positive position. Since 1999, the Parish has met its financial commitments without any assistance from the Northern Region in the form of grants. This year the parish has three student ministers assisting with various ministry tasks.

6. For the last two years, the Annual Vestry Meeting has discussed the church's finances, and parishioners have expressed the desire to apply for full parish status in accordance with the relevant ordinances. At the Parish Council on 2 May 2001, a resolution was passed to apply for full parish status.

Parish information

7. The population of the Parish is 13,385, of which 3,495 (26%) claim affiliation to the Anglican Church of Australia. The population is young with lots of young families in the area. Over 50% of the total population is under 40 years of age. Harbord has one of the highest birth rates in Sydney. The local Infants and Primary School, Harbord Public, has over 700 students and is currently embarking on an extended building plan.

8. The overwhelming majority of the population have English as their only language, 10,775 and 9,394 were born in Australia (over 70%). There is a relatively small number of residents who have never married, 30.6%. Most people either own their dwelling or are in the process of paying it off. Only 2,043 (33%) of dwellings are

rented premises. Harbord has great demographics for gospel based ministry and growth.
