Proposal to change the status of the Provisional Parish of Seven Hills to a Parish

(A report from the Western Sydney Regional Council.)

Initiation of proposal

1. A proposal was made to the Archbishop by the minister and churchwardens of the Provisional Parish of Seven Hills under clause 4(1)(b) of the Parishes Ordinance 1979.

Details of meeting

- 2. A meeting of the Western Sydney Regional Council held on 21 June 2001 considered the proposal under clause 5 of the Ordinance.
- 3. Western Sydney Regional Council certified that all procedural requirements under clauses 4 and 6 have been complied with.

Proposal

- 4. The proposal is to change the Provisional Parish of Seven Hills to the Parish of Seven Hills.
- 5. The Provisional Parish has applied following the growth in membership and ministry in the Seven Hills area.

Parish Information

- 6. There has been a sustained growth in the numbers attending and a further full-time lay stipendiary worker has been employed.
- 7. In the 1996 NCLS profile a total of 3,123 persons out of 14,843 persons claim affiliation with the Anglican Church (21.1%), 1368 or (9.2%) claim no religion and a further 902 (6.1%) did not state a religion. The largest group outside Christian Religions was 500 (3.4%) Muslim. 56.1% of the total population are married and 68.4% purchasing a private dwelling.
- 8. The Provisional Parish employs a full-time lay stipendiary pastoral worker following a period as a part-time worker.
- 9. The Provisional Parish now has 135 adults regularly attending as follows -

9:00 am 65 10:30 am 35 6:30 pm 35

10. Ministry amongst youth averages 25 each week and 16 attend Kids' Club on Fridays. Scripture in schools is carried out regularly.
