Proposal to reclassify the provisional parish of Gerringong as a parish

(A report from the Wollongong Regional Council.)

Initiation of proposal

1. A proposal was made to the Archbishop by the Minister and Churchwardens of the provisional parish of Gerringong under clause 4 (1)(b) of the Parishes Ordinance 1979.

Details of Meeting

2. A meeting of the Wollongong Regional Council (WRC) was held on 11 June 2002 to consider among other things, the proposal under clause 5 of the Ordinance.

3. WRC certified that all procedural requirements under clauses 4 and 6 have been complied with.

Proposal

4. The proposal is to change the provisional parish to a parish.

Parish Information

5. Gerringong has grown in recent years and there has been a steady growth in attendances at both centres.

6. The total population of the two areas is approximately 6,700. Some 2,860 people still claim affiliation with the Anglican Church. The churches serve the areas of Gerringong and its hinterland and the village of Shoalhaven Heads further south.

7. Both communities are attractive to retirees, although numbers of young people continue to buy into the areas - housing remains affordable although prices are rising in line with trends generally. The percentage of non English speaking people in the communities is low and generally both areas are typically middle Australia.

8. The Provisional Parish employs a Curate in Charge, the Rev Andrew Glover, an Assistant Minister, the Rev Ross Maltman (Based in Shoalhaven Heads) together with a part time Youth Worker. The Provisional Parish at both centres has sought to reach out to its local area particularly amongst the younger people.

9. There are two public primary schools in the Parish.

10. The provisional parish currently has 154 regular worshippers with average attendances as follows -
