

## **Proposal to reclassify the provisional parish of Kingswood as a parish**

(A report from the Western Sydney Regional Council.)

### **Initiation of proposal**

1. A proposal was made to the Archbishop by the minister and churchwardens of the provisional parish of Kingswood under clause 4(1)(b) of the Parishes Ordinance 1979.

### **Details of Meeting**

2. A meeting of the Western Sydney Regional Council held on 4 July 2002 considered the proposal under clause 5 of the Ordinance.

3. The Western Sydney Regional Council certified that all procedural requirements under clauses 4 and 6 have been complied with.

### **Proposal**

4. The proposal is to change the provisional parish of Kingswood to the parish of Kingswood.

5. The provisional parish has applied for a change in classification following the growth in membership and ministry in the Kingswood area.

### **Parish Information**

5. In the 1996 NCLS profile a total of 2,748 persons out of 11,274 persons claim affiliation with the Anglican Church (224.6%), 1,308 or (11.7%) claim no religion and a further 987 (8.8%) did not state a religion. The largest group outside Christian religions was 218 (2.0%) Muslim. 53.4% of the total population are married and 58.9% are purchasing a private dwelling.

6. A minister and assistant minister are licensed to the provisional parish and the provisional parish employs a catechist and a UWS chaplain (mostly paid for by grant).

7. The provisional parish now has 122 adults regularly attending as follows -

8. Ministry amongst youth averages 36 each week and amongst children averages 28. Scripture in schools is carried out regularly. Other activities include 7 bible study groups and seniors and craft groups.
