South Sydney Regional Council Annual Report for 2005

(A report from the South Sydney Regional Council.)

Introduction

1. The Council met on six occasions during 2005, four times at Meriden School, Strathfield, and twice at St Andrew's Cathedral School in the city. The Council of 2005 saw the ending of a very happy relationship with Meriden School who have accommodated us for nearly ten years. However, the move to the city location with its accompanying meal before the Council meeting has proved to be very popular and helpful.

Ministry Strategies

4. This oldest region of the Diocese continues to undergo exciting and substantial change and rejuvenation. Council has continued to work hard at the implications of the Diocesan Mission for churches and ministries in the South Sydney Region. We employed the Rev Stuart Robinson one day a week to consult with ten parishes in our region over about how to be more involved in our Mission. We oversaw the creation of the provisional parish of Pyrmont and the amalgamation of Bondi with Bondi Beach into a new parish. Lord Howe Island was separated from Malabar and returned to being a

provisional parish in its own right while Malabar saw the insertion of the Asian Australian Bible Church in what has proved to be a very happy joining of two ministries under the leadership of the Rev Andrew Moore.

- 5. Council also helped manage the proposal by the New Capital Project to consult with five of our parishes, with four of those parishes agreeing to participate. In the end no further action has been taken.
- 6. Council also continued to fund the employment of assistant ministers in parishes employing assistant ministers for the first time, namely Annandale and Concord West, with the aim of increasing significantly the ministry impact of those parishes.
