Proposal to change the status of the provisional parish of Wilberforce to a parish

(A report from the Western Sydney Regional Council)

Initiation of Proposal

1. A proposal was made to the Archbishop by the minister and churchwardens of the provisional parish of Wilberforce under clause 4(1)(b) of the Parish Ordinance of 1979 (the "Ordinance").

Details of Meeting

- 2. On 18 August 2006 the Western Sydney Regional Council considered the proposal under clause 5 of the Ordinance, accepted the recommendation and endorsed the proposal.
- 3. All the procedural requirements under clause 4 of the Ordinance have been satisfied.

Proposal

- 4. The proposal is to change the provisional parish of Wilberforce to the parish of Wilberforce.
- 5. The provisional parish has applied following the growth in membership and ministry in the Wilberforce area.

Parish Information

- 6. The parish began in the mid nineteenth century and contains one of the colonies earliest school houses.
- 7. The provisional parish now employs four full time ministers, a student minister, a Youthworks college student and an office secretary.
- 8. The provisional parish now has over 300 adults regularly attending as follows:

- 9. In 2000 the church pioneered and commenced the Arndell Community Anglican Church, which has grown and become a separate parish unit in the College.
- 10. In 2005 they started a church plant Glossodia Community Anglican Church, which meets in the local school. This has grown to 37 adults and 9 children over the last 15 months.
- 11. There are over 100 children attending each Sunday and are running 2 youth groups, 2 children's clubs and 3 Sunday Schools and 32 classes of scripture are taught each week. During school holidays we hold a day camp for children.
