Proposal to change the status of the provisional parish of Artarmon to a parish

(A report from the Northern Regional Council.)

Proposal

1. A proposal was made to the Archbishop by the minister and wardens of the provisional parish of St Basil's, Artarmon under clause 4 of the Parishes Ordinance 1979 for reclassification as a parish.

Details of meeting

- 2. A meeting of the Northern Regional Council held on 19 August 2009 considered the proposal under clause 5 of the Parishes Ordinance.
- 3. The Northern Regional Council certifies that all procedural requirements under clauses 4 and 6 of the Parishes Ordinance have been completed, and recommends that the Synod raise the status of the provisional parish to a parish.

Parish information

- 4. The parish of Artarmon was reclassified a provisional parish in 1998 following declining revue and attendance during the incumbency of the Rev. Thomas Hall. In May 2007, the Rev. Ernest Chau became the Curate-in-Charge having brought his mainly Chinese congregation from St John the Baptist Kirribilli to St Basil's. St John's continues to be a provisional parish because of its lack of a rectory-standard residence for the incumbent. Since Artarmon already had a rectory-standard residence, the upsurge in numbers attending enabled the revenue to be lifted to the threshold of a full parish.
- 5. In the current year, regular attendance at St Basil's is as follows $\,$

9.15 am (English service) 50 11.00 am (Cantonese service) 110

6. The parish has plans to expand services in the near future with a Mandarin service and a contemporary English service.
