

Asbestos Inspection (Special Charge) Ordinance 2007

Asbestos inspection charge for 2010

(A report from the Standing Committee.)

Background

1. In passing the Asbestos Inspection (Special Charge) Ordinance 2007 (the "Ordinance"), Synod approved the funding and implementation of the Parish Asbestos Inspection Program (the "Program") that will result in all parish properties being inspected by the end of 2012. The Program is being managed by the Anglican Church Property Trust (the "Property Trust").
2. Funding for the Program comes from a charge levied on the net [operating] receipts of parishes with real property through the Parish Cost Recoveries System ("PCR"), in accordance with the Ordinance. For 2009 the percentage charge was 0.46% (2008 0.46%).
3. This report has been prepared under clause 3(3) of the Ordinance which requires the Standing Committee to report to each session of the Synod about –
 - (a) an estimate of the costs of the Program payable in the following year, and
 - (b) the asbestos inspection charge estimated to be payable by each relevant parochial unit in the following year and details of how that charge is calculated.

Inspection progress to date

4. In February 2008, 3 consultants were engaged for an initial 12 month period to March 2009 during which 166 "standard" sites (a church, hall and rectory is counted as 1 standard site for these purposes) from 115 parishes were inspected.
5. The number of sites inspected during April to June 2009 was restricted to a reinspection of a small number of sites for quality assurance purposes to allow for an assessment of the tenders for the 2009/2010 program, as part of the ongoing oversight by the Property Trust.
6. In August 2009, in light of the quality assurance review conducted, 2 consultants were engaged by the Property Trust for the 2009/10 inspection program.
7. Given the operational capacity of the consultants and the amount of funds forecast to be recovered from parishes through PCR in 2009, it is expected that a further 120 standard sites will be inspected by December 2009.

8. Based on a projection of inspections it is expected that the Program will be substantially complete by late 2011, which is ahead of original projections.

9. Inspections to date have focused on those parishes that it was considered by the individual parish, regional Archdeacon and Parish Services were most likely to have asbestos related issues. The inspection schedule is being constantly updated to accommodate ongoing advice from parishes regarding potential for asbestos related issues.

10. Asbestos containing material ("ACM") and lead based paint have been found at the majority of sites inspected year to date, albeit the vast majority of ACM has been deemed to be of 'low risk' that in many cases only requires ongoing annual inspection and management by the parish. In other cases minor remedial work will be undertaken (e.g., applying sealant to broken edges).

11. The presence of ACM was identified as being of 'medium' risk at 3 parishes that upon the recommendation of the consultant required remedial works to be undertaken. The cost of those remedial works will be borne by each parish.

Funding for 2010

12. It is expected that during 2010 there will be up to 150 standard sites inspected at a total cost of about \$325,000 (2009 \$320,000). The main component of the cost of the Program in 2010 is the fees of the asbestos inspectors estimated at \$225,000, with the balance comprising SDS administration fees estimated at \$100,000.

13. Although this estimated total cost is \$15,000 more than contemplated for 2010 in the explanatory material for the Ordinance, it is expected that this will enable 150 inspections to be completed in 2010 compared with the 100 that had originally been planned.

14. The majority of the estimated total cost of the Program for 2010 will be funded from a continuation of the asbestos inspection charge calculated at 0.44% of the net [operating] receipts of each parochial unit (other than those for which no real property is held) for 2008 under the Cost Recoveries Framework Ordinance 2008.

15. A table showing the amount of the proposed parish inspection charge in 2010 for each parochial unit based on 0.44% of net [operating] receipts for 2008 is set out in the Appendix.
