## St. Aidan's Moorebank Variation of Trust and Land Sale Ordinance 1964 Amendment Ordinance 1965

## No. 3, 1965.

AN ORDINANCE to amend Ordinance No. 27, 1964 entituled "St. Aidan's Moorebank Variation of Trust and Land Sale Ordinance 1964."

WHEREAS by Ordinance No. 27, 1964 entituled "St. Aidan's Moorebank Variation of Trust and Land Sale Ordinance 1964" the sale of land described in the Schedule thereto was authorised and it was provided by Clause 6 (ii) of such Ordinance that two thirds of net proceeds of sale should be applied firstly towards a residence for a Curate in the Provisional District of Hammondville and secondly towards the purchase of new sites for Churches, Church Halls or other psychial buildings in the areas known as Hammondville, Chipping Norton and Moorebank within the said Provisional District and the erection of such buildings thereon AND WHEREAS the said land has been sold pursuant to such Ordinance AND WHEREAS by reason of circumstances which have arisen subsequent to the creation of the trusts upon which the said proceeds of sale are to be held it is expedient that the said trusts be varied as hereinafter set out and it is appropriate that the said Ordinance be amended accordingly NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY DECLARES ORDAINS AND DIRECTS as follows:-

- I. St. Aidan's Moorebank Variation of Trust and Land Sale Ordinance 1964 (No. 27, 1964) is in this Ordinance referred to as the Principal Ordinance.
- 2. This Ordinance may be cited as "St. Aidan's Moorebank Variation of Trust and Land Sale Ordinance 1964 Amendment Ordinance 1965".
- 3. The Principal Ordinance as amended by this Ordinance may be cited as "St. Aidan's Moorebank Variation of Trust and Land Sale Ordinance 1964-1935".
- 4. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the moneys referred to in Sub-Clause (ii) of Clause 6 of the Principal Ordinance are held it is inexpedient to carry out and observe the same in their entirety and it is expedient that the said trusts be varied as provided by the amendment of the said Sub-clause as hereinafter set out.

## St. Aidan's Moorebank Variation of Trust and Land Sale Ordinance 1964 Amendment Ordinance 1965

5. Sub-clause (ii) of Clause 6 of Ordinance No. 27, 1964 is hereby amended by deleting therefrom the words "firstly towards a residence for a Curate in such Provisional District of Hammondville and secondly towards."
