

*"St. Andrew's Cathedral Building Ordinance 1937."*

No. 9, 1937.

AN ORDINANCE to authorise the Standing Committee to act in the matter of carrying out the works referred to in the Conditions for the Competition for the Extension of St. Andrew's Cathedral and other buildings and for other purposes.

WHEREAS by Saint Andrew's Cathedral Site Act 1935 certain lands were vested in Church of England Property Trust Diocese of Sydney (hereinafter called the Corporate Trustees) for the purposes of the said Cathedral and such land together with other lands previously vested in the Corporate Trustees for the like purposes are now comprised and described in Certificate of Title Registered Volume 4804 Folio 186.

AND WHEREAS certain buildings (hereinafter referred to as the "vested buildings") are situated upon the lands vested as aforesaid by the said Act.

AND WHEREAS it is expedient to make provision for the management of and dealing with the said lands and the vested buildings and the revenues arising therefrom.

AND WHEREAS it is also expedient to make provision for carrying out the works referred to in the Conditions for the Competition for the Extension of St. Andrew's Cathedral and other buildings the promotion of which Competition was authorised by "St. Andrew's Cathedral Building Ordinance 1936."

Now Therefore the Synod of the Diocese of Sydney Ordains as follows:—

1. The Standing Committee of the Synod of the Diocese of Sydney is hereby empowered to do or authorise to be done all acts deeds matters and things which it may deem proper and expedient for the purpose of or in connection with or incidental to:—

- (a) The repair alteration improvement user letting investment and management of or otherwise dealing with the vested buildings and the lands comprised in the said Certificate of Title and the moneys hereinafter referred to.
- (b) The whole or any part of the scheme of buildings and works in respect of which the said competition was promoted—as the same are more particularly set forth in the said Conditions in accordance with the design placed first in terms of such Conditions with such modifications thereof (if any) as the Standing Committee may determine.

- (c) The laying of the foundation stone or stones of any of the buildings mentioned in the said Competition and if possible in Easter Week in the year 1938.
2. For all or any of the purposes aforesaid the Standing Committee is hereby authorised:—
- (a) To appoint constitute and nominate sub-committees select committees or other bodies and persons not necessarily comprising or being members of the said Synod.
- (b) To give to and confer upon such committees bodies and persons and to the Corporate Trustees such directions powers and authorities as the Standing Committee shall deem advisable.
- (c) To raise moneys by way of donations and subscriptions.
- (d) To direct and control the expenditure of all moneys:—
- (i) Raised by way of donations or subscription.
- (ii) Paid or payable pursuant to St. Andrew's Cathedral Site Act 1935.
- (iii) Paid or payable for or on account of the use occupation or letting of any of the vested buildings.
- (iv) Arising from the investment of any of the said moneys.

3. And so far as it lawfully can and may, this Synod hereby authorises the Standing Committee to do or authorise to be done all acts deeds matters and things not otherwise in this or St. Andrew's Cathedral Building Ordinance 1936 provided for in and about the said lands buildings works and Competition.

4. This Ordinance may be cited as the "St. Andrew's Cathedral Building Ordinance 1937."
