*St. Anne's Hammondville Land Sale Ordinance 1968  
Amendment and Variation of Trusts Ordinance 1970*

AN ORDINANCE to amend St. Anne's Hammondville Land Sale Ordinance 1968 (No. 34, 1968).

WHEREAS by St. Anne's Hammondville Land Sale Ordinance 1968 (No. 34 1968) (hereinafter called the "Principal Ordinance") Church of England Property Trust Diocese of Sydney was authorised to sell certain land at Hammondville as described in the Second Part of the Second Schedule of such Ordinance AND WHEREAS the Principal Ordinance directed (inter alia) that the net proceeds arising from the sale or sales of such land be applied in accordance with paragraphs (i) (ii) and (iii) of clause 3 of the Principal Ordinance AND WHEREAS by reason of circumstances which have arisen subsequent to the creation of the trusts of such proceeds it is inexpedient to carry out and observe the same to the extent that the same are hereby varied AND WHEREAS it is expedient that the Principal Ordinance be amended as hereinafter set out NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of such Synod HEREBY DECLARES RULES AND ORDAINS as follows:—

1. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the proceeds of sales of the said land are held it is inexpedient to carry out and observe the same to the extent that the same are hereby varied.

2. Clause 3 of the Principal Ordinance is amended by omitting all of the words following the words "pursuant thereto be" and inserting in lieu thereof the following words:—

"paid to the Churchwardens of St. Thomas' Church Moorebank to be applied by them in reduction of the outstanding moneys borrowed for the erection of the church building known as St. Thomas' Moorebank".

3. The Principal Ordinance as amended by this Ordinance may be cited as "St. Anne's Hammondville Land Sale Ordinance 1968-1970".

4. This Ordinance may be cited as "St Anne's Hammondville Land Sale Ordinance 1968 Amendment and Variation of Trusts Ordinance 1970".
