AN ORDINANCE to vary the trusts of part of certain moneys held by Church of England Property Trust Diocese of Sydney upon trust for St. David's Church of England Burrawang in the Pairsh of Wingecarribee.

WHEREAS by Ordinance No. 10 1956 entituled "Wingecarribee (St. David's Burrawang) Sale Ordinance 1956" it was directed that the net proceeds of the sale of the land described in the Schedule to that Ordinance (hereinafter called the Principal Ordinance) should be invested by Church of England Property Trust Diocese of Sydney (hereinafter called the Corporate Trustee) in accordance with the provisions of the "Investment of Church Trust Property Ordinance 1944" or any ordinance amending or taking the place of the same and the net income arising from such investments paid to the Churchwardens for the time being of St. David's Church Burrawang for general church purposes AND WHEREAS the net proceeds of such sale amounted to the sum of Six thousand four hundred and forty pounds eight shillings and sevenpence (£6,440 8s. 7d.) AND WHEREAS it is expedient that part of the said capital moneys to the extent of Two thousand pounds (£2,000) be applied in and towards the purchase of the land described in the Schedule hereto and the erection thereon of a hall to be used in connection with the said church of St. David's Burrawang AND WHEREAS by reason of circumstances which have arisen subsequent to the creation of the trusts upon which the said capital moneys are now held it is inexpedient to carry out and observe the same in their entirety and it is expedient to vary the said trusts as hereinafter set out Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod hereby ordains and directs as follows:-

1. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the moneys paid to the Corporate Trustee in pursuance of the said Principal Ordinance are held it is inexpedient to carry out and observe such trusts in their entirety and it is expedient that the same be varied to the extent hereinafter set out.

- 2. The Corporate Trustee shall hold the sum of Two thousand pounds (£2,000) part of such moneys upon trust to pay the same to the Churchwardens for the time being of St. David's Church Burrawang to be applied by them in and towards the purchase of the land described in the Schedule hereto and the costs charges and expenses of and incidental to this Ordinance and of the transfer of the said land and the erection thereon of a hall to be used in connection with the said church.
- 3. This Ordinance may be cited as "St. David's Burrawang Variation of Trust Ordinance 1957."

SCHEDULE.

All that piece or parcel of land situated at Burrawang in the Shire of Wingecarribee Parish of Yarrunga County of Camden having a frontage of about 138 feet 3½ inches to Dale Street being Lots 22 and part of Lots 20 and 21 D.P. 1992 and being part of the land comprised in Certificate of Title Volume 7040 Folios 164 and 165.
