An Ordinance to vary determine and appoint the application of the rents and profits of the old parsonage site of the Church of St. James situate at Sydney in the County of Cumberland as set out in the "Saint James' Parsonage Act 1912" and Ordinances thereon and for other purposes incidental thereto.

WHEREAS by the "St. James' Parsonage Act 1912 Church Fund Ordinance of 1938" it was enacted that for the period from the First day of April One thousand nine hundred and thirty-eight to the Thirty-first day of March One thousand nine hundred and thirty-nine and thereafter for such further period or period as the Standing Committee shall by resolution determine not extending beyond the Thirty-first day of March One thousand nine hundred and forty-three or to the earlier sale of St. James' Parish Hall sub-section (c) of Section 5 of the "St. James' Parsonage Act" as amended by the "St. James' Parsonage Act 1912 Rates and Taxes Ordinance of 1936" shall be read as if after the word "quarterly" the words "and a further sum less by Four hundred pounds (£400) per annum reckoned quarterly" were inserted therein. AND ALSO for the same period sub-section (d) of the same Act and Section as amended by the "St. James' Parsonage Act Rates and Taxes Ordinance of 1936" shall be read as if the following words were added after the word "Hall" "and a further sum of Four hundred pounds (£400) per annum reckoned quarterly to be paid to the Rector and Churchwardens for the time being of the Church of St. James Sydney whose receipt shall be a sufficient discharge to be dealt with in pursuance of the "Sydney Church Ordinance 1912" or any ordinance amending or taking the place of the same and applied by them towards maintaining the said Church and in or towards the payment of the Clergyman duly appointed to officiate at the said Church." AND WHEREAS the said ordinance having expired it is expedient to continue such provisions in manner hereinafter appearing. Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and declares as follows:--

- 1. By reason of circumstances subsequent to the passing of the said recited Act and the Ordinances thereon it is expedient to vary further determine and oppoint the provisions of sub-sections (c) and (d) of Section 5 of the said Act in the following particulars:—
 - (a) For the period from the First day of April One thousand nine hundred and forty-three to the Thirty-first day of March One thousand nine hundred and forty-four and thereafter for such further period or periods not exceeding one year on each occasion as the Standing Committee shall by resolution determine or to the earlier sale of St. James' Parish Hall subsection (c) of Section 5 of the "St. James' Parsonage Act" as amended shall be read as if after the word "quarterly" the words "and a further sum less by Four hundred pounds (£400) per annum reckoned quarterly" were inserted therein.
 - (b) For the same period sub-section (d) of the same Act and Section as amended shall be read as if the following words were added after the word "Hall" "and a further sum of Four hundred pounds (£400) per annum recknoned quarterly to be paid to the Rector and Churchwardens for the time being of the Church of St. James Sydney whose receipt shall be a sufficient discharge to be dealt with in pursuance of the "Sydney Church Ordinance 1912" or any Ordinance amending or taking the place of the same and applied by them towards maintaining the said Church and in or towards the payment of the Clergyman duly appointed to officiate at the said Church."
- 2. This Ordinance shall be read as supplementary to all former Ordinances but shall in no way affect the provisions of the "St. James' Sydney Parish Sale Ordinance of 1935."
- 3. This Ordinance she" be styled and cited as the "St. James' Parsonage Act 1912 Church Fund Ordinance of 1943."
