



St James' South Canterbury Variation of Trusts and Sale Ordinance 1986 Amendment Ordinance 1996

No 23, 1996

Long Title

An Ordinance to amend the St James' South Canterbury Variation of Trusts and Sale Ordinance 1986.

Preamble

Whereas

A. By the St James' South Canterbury Variation of Trusts and Sale Ordinance 1986 (the "Principal Ordinance") the churchwardens of St Alban's Church Belmore ("Churchwardens") are required by 30 June 1996 to promote an ordinance to deal with funds held by the Property Trust under the Principal Ordinance after 30 September 1996.

B. The Churchwardens at the request of the Parish Council now propose amendments to the Principal Ordinance as provided for hereafter.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows -

Name of Ordinance

1. This ordinance is the St James' South Canterbury Variation of Trusts and Sale Ordinance 1986 Amendment Ordinance 1996.

Amendment of Principal Ordinance

2. Clause 4 of the Principal Ordinance is amended as follows -

(a) in paragraph (c) after the matter "thirdly," the following is inserted -

"up to and including 30 September 1996";

(b) in paragraph (c) the following matter is omitted -

"up to and including the Thirtieth day of September 1996 and the churchwardens for the time being of St Alban's Belmore shall prior to the Thirtieth day of June 1996 make application to the Standing Committee for an ordinance to deal with the disposition of the said balance as to capital and income after the Thirtieth day of September 1996"; and

(c) after paragraph (c) a new paragraph (d) is inserted -

"(d) fourthly, after 30 September 1996 and including 30 September 2001 the Corporate Trustee must pay out of the capital the sum of \$5,000 for expenditure upon the church building known as St Mark's Church Clemton Park and hold the balance of the capital sum and apply the income as follows-

(i) 30% of the income must be capitalised; and

(ii) the remaining 70% of the income must be paid to the churchwardens for the time being of St Alban's Church Belmore to be applied for such purposes within or without the Amalgamated Parish as the Parish Council may from time to time determine."

3. After clause 4 of the Principal Ordinance, a new clause 5 is inserted as follows -

"5. The churchwardens for the time being of St Alban's Church Belmore shall, prior to 30 June 2001, make application to the Standing Committee for an ordinance to deal with the disposition of the said balance as to capital and income after 30 September 2001."
