AN ORDINANCE to authorise the transfer of a strip of land adjacent to the boundary of property of the Church of St. John Rockdale.

WHEREAS:

- A. Pursuant to the St. John Rockdale Sale Ordinance 1979, the land comprised in Certificate of Title Volume 8044 Folio 68, together with improvements thereon, was sold and transferred to the Council of the Municipality of Rockdale (which said land is herein referred to as "the land originally sold").
- B. Anglican Church Property Trust Diocese of Sydney (hereinafter called "the Corporate Trustee") is the registered proprietor of land being church trust property which is adjacent to the land originally sold and upon which said land is constructed a church building, which said land (hereinafter called "the adjacent land") is the whole of the land comprised in Certificate of Title Volume 1211 Folio 57.
- C. The adjacent land is held upon trust for the purposes of a church parsonage or parish hall or partly for one or partly for another of such purposes such trusts having been declared in the "St. John's Rockdale Mortgaging Ordinance 1938".
- D. The said Council has informed the Corporate Trustee that certain buildings constructed upon the land originally sold encroach as to part upon the adjacent land.
- E. The Corporate Trustee at the request of the said Council has agreed subject to the terms of this Ordinance that part of the adjacent land shall be transferred to the said Council which said part of the adjacent land is shown as the area hatched in the sketch plan annexed to this Ordinance and marked with the letter "A" (hereinafter called "the subject land)".
- F. It is inexpedient to carry out and observe the trusts with respect to the subject land and it is expedient that the subject land be transferred upon the terms and conditions herein set forth.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows.

- 1. By reason of the circumstances which have arisen subject to the creation of the trusts upon which the subject land is held it is inexpedient to carry out and observe the same and it is expedient that the subject land be transferred.
- 2. The Corporate Trustee is hereby empowered to transfer the subject land by private contract to the said Council at such time and upon such conditions as are set forth herein and otherwise upon such other terms and conditions as it shall think fit freed from the trusts upon which such land is now held.

- 3. The transfer of the subject land will be made without consideration but the said Council has agreed:
 - (a) to pay all costs incurred by the Corporate Trustee of and incidental to the transfer and this Ordinance;
 - (b) to construct certain fencing works on the new boundary between the subject land and the residue of the adjacent and;
 - (c) to enter a restrictive convenant whereby no building, construction, fixture, structure or fixture of any kind shall be erected, constructed or built or shall be permitted to remain or be maintained, erected, constructed or built on the subject land save and except that the terms hereof shall not apply to the brick building, Nursing Service Store and any other building, construction, fixture or structures which at the date hereof are constructed upon the subject land; and
 - (d) to grant a licence to the Corporate Trustee for the nonexclusive right to go, pass and repass at all times and for all purposes with or without vehicles over part of the land originally sold and the subject land pursuant to various terms and conditions which have been agreed upon between the Corporate Trustee and the said Council.
- 4. This Ordinance may be cited as "St. John's Rockdale Transfer (Additional Land) Ordinance 1987".
