# ST. PAUL'S CARLINGFORD ORDINANCE 1976 <br> No. $44 \quad 1976$ 

AN ORDINANCE to declare the trusts of certain land in the Shire of Baullcham Hills to authorise the moxtgaging of such land to provide for the aprlication of the proceeds of such mortgaging and for purposes incidertal thereto.

WHEREAS Church of England Property. Trust Diocese of Sydney bedy
corporate-under-therchuroh-of [nginand (Bodfes Corporate) Act 1998
(hereinafter called the "Corporate Trustee") is the proprietor of the land described in the schedule hereto (hereinafter called "the said
land") AND WHEREAS the said land is to be held for the purposes of constructing thereon a church parish hall and other appurtenant buildings and rectory for the church of St. Paul at Carlingford but no trusts have been declared in writing concerning the same AND WHEREAS the Bank of New South Wales Savings Bank Limited has agreed subject to the Standing Cormittee of the Synod of the Diocese of Sydney passing an ordinance authorising the mortgaging of the said land to secure such borrowing to provide an amount of Fifty thousand dollars ( $\$ 50,000$ ) to provide for the cost of construction of the said rectory and initial cost of construction of the said church AND WHEREAS it is expedient that the said land be mortgaged NOW the Standing Comittee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY DECLARES DIRECTS ORDAINS AND RULES as follows:-

1. The said land shall henceforth be held upon trust for a church parish hall and other appurtenant buildings and rectory or paxtly for one or another or others of such purposes in connection with the Church of England In Australia at.Carlingford in the Parish of St. Paul Carlingford. 2. By reason of clrcumstances which have axisen subsequent to the creation of the trusts on wich the asfl land is held it is expedient to mortgage the said land.
2. The Corporate Trustee is hereby authorised to mortgage the said land for the purpose of borrowing the sum of Fifty thousand dollars $(\$ 50,000)$ provided that the said amount shall be reduced by monthly repayments of at least Four hundred and sixty four dollars (\$464) each on account of principal and interest commencing thirty (30) days after the whole amount is fully drawn.
3. (1) The proceeds of any mortgage duly authorised by this ordinance shall be appliad first in payment of the costs of and incidental to this ordinance the costs of and incidental to any mortgage or charge executed in pursuance of this ordinance and the balance shall be applied towards the cost of erection of the said rectory and church.
(2) Any mortgagee advancing moneys pursuant to the provisions of this ordinance is hereby authorised to pay the same direct to the churchwardens for the time being of the Church of St. Paul at Carlingford, 5. The said churchwardens shall within seven (7) days of the date of holding an annual vestry meeting during such time as any money is owing to any mortgagee pursuant to this ordinance cause an account to be forwarded to the Secretary of the Corporate Trustee giving details of the original anount borrowed the amounts paid off and the balance owing as at the end of the previous finar cial year.
4. This ordinance may be cited as "St. Paul's Carlingford Oradnance $1976^{\prime \prime}$.

## SCHEDULE

ALL THAT piece or parcel of land situate in the County of Cumberland Parish of Field of Mars and Shire of Baulkham Hills having an area of 6320 sq metres being Lot 34 in Deposited Plan No. 251044 and being the whole of the land comprised in Certificate of Title Volume 12998 Folio 161.
