

Sydney Anglican Schools Corporation Ordinance 1947 Amendment Ordinance 1993

No 23, 1993

An Ordinance to amend the Sydney Anglican Schools Corporation Ordinance 1947.

Whereas it is expedient to amend Sydney Anglican Schools Corporation Ordinance 1947(the "Principal Ordinance").

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod Hereby Ordains as follows -

1. This Ordinance may be cited as "Sydney Anglican Schools Corporation Ordinance 1947 Amendment Ordinance 1993".

2. The Principal Ordinance is amended as follows -

- (a) in clause 1.1 the word "by" is omitted from the definition of "Standing Committee Appointee";
- (b) in clause 1.1 the word "the" is substituted for "a" in the definition of "Synod Appointee";
- (c) in clause 3.1(b) the words "up to" are inserted before "six (6)" and in both places before "three (3)";
- (d) in clause 3.1(e) the words "up to" are inserted before "four (4)";
- (e) the following is substituted for clause 4(b) -

"Each Member elected by the Synod holds office (subject to Clause 6) until the first day of the ordinary session of the Synod in the third year after the year in which the Member is elected or re-elected. Each Member appointed by the Corporation holds office (subject to Clause 6) until the first meeting of the Corporation held after the first day of the ordinary session of the Synod in the third year after the year in which the Member is appointed or reappointed. Each other Member (apart from the Archbishop) holds office (subject to Clause 6) until the first meeting of the Standing Committee held after the first day of the ordinary session of the Synod in the third year after the year in which the Member is appointed, elected, re-appointed or re-elected.";

3. in clause 5 the following is inserted after "other office bearers" where first appearing -

"shall be for terms of up to 3 years expiring on the first meeting of the Corporation held after the first day of the ordinary session of the Synod in any year and".

- (a) the word "or" where lastly appearing in clause 6.1(e) is omitted and the following is inserted at the end of clause 6.1 -
 - "; or
 - (g) the member retires or otherwise ceases to hold office.";
- (b) clause 6.3 is deleted and clause 6.4 is re-numbered as clause 6.3;
- (c) in clause 7.3(b), the word "as" is inserted after "conditions";
- (d) at the end of clause 7.3(g) the following is inserted -
 - "The Chief Executive Officer of the Corporation (or his delegate) may attend and participate in any or all meetings of the School Council of a School but may not vote.";
- (e) in clause 7.5 the word "cease" is substituted for "case" where secondly appearing;
- (f) in clause 9.1(b) the word "at" is inserted after "present";
- (g) in clause 9.1(c)(i) the word "willing" is substituted for "wiling";
- (h) in clause 10.2(j) the word "or" is substituted for "of";
- (i) in clause 10.3(c) the word "within" is substituted for "with" where first appearing;
- (j) in clause 10.4 the word "persons" is substituted for "person";
- (k) in clause 14.1(b) the word "other" is substituted for "either"; and
- (l) from the schedule the following is omitted -

"Roseby Preparatory School Dee Why
St Luke's College Dee Why
Peninsular Grammar School Warriewood"

and the following is added -

"St Luke's Grammar School Dee Why"
