ORDINANCE. SYDNEY CHURCH OF ENGLAND GIRLS' GRAMMAR SCHOOL.

(As Passed.)

AN ORDINANCE to further amend the "Sydney Church of England Girls' Grammar School Ordinance of 1895" and for other purposes.

The Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the Church of England within the State on New South Wales and of all other powers vested in the said South of orders and rules as follows:—

- 1. Section 1 of the "Sydney Church of England Girls' Grammar School Ordinance of 1895" is hereby repealed and the following inserted in its place namely:—
 - "1. The Council of the said School shall consist of the Archbishop of the Diocese of Sydney as President ex-officia and of fifteen members to be elected and to retire as follows:—.
 - "(a) Four clergymen and four laymen to be elected by Synod Provided that the three clergymen and three laymen now holding office shall continue to hold office and shall retire as if the said Ordinance as amended by this Ordinance had been in force when they were elected and they were elected thereunder and that one additional clergyman and one additional layman shall be elected by Synod after the election of the one additional woman hereinafter mentioned Provided further that when Synod is not in Session the Standing Committee may elect such additional clergyman and layman. One clergyman and one layman shall

retire at the first succeeding Session of Synod; one clergyman and one layman shall retire at the second succeeding Session of Synod; and two clergymen and two laymen shall retire at the third succeeding Session of Synod and so on in rotation at all succeeding Sessions of Synod. The retirement shall be according to priority of election and retiring members shall be cligible for re-election.

- "(b) Six women to be elected by Synod. Provided that the six women now holding office shall continue to hold office and shall retire as if the said Ordinance as amended by this Ordinance had been in force when they were elected and they were elected thereunder. Two women shall retire annually according to priority of election and shall be eligible for re-election.
- "(c) One woman who shall from time to time be elected by and from the members of any Old Girls' Union or other organisation in connection with the said School and shall hold office for three years but shall be eligible for re-election."
- 2. The said election by and from the members of any such organisation as aforesaid shall be carried out through the post at the cost of such organisation but by and under the direction of the Archbishop-in-Council.
- 3. The validity and result of any such election so carried out through the post as aforesaid and all questions with regard thereto and to the order of retirement under this Ordinance shall be determined by the Archbishop-in-Council and such determination shall be final and conclusive.

- 4. No omission to elect any member or members nor any informality or error in the method of any such election nor any vacancy or vacancies in the office of member shall affect the authority or powers of the Council and subject to the provision as to a quorum all such authority and powers may be exercised by the members for the time being holding office.
- 5. Section four of the said Ordinance is hereby amended by omitting the word "Bishop" and inserting in each place "Archbishop,"
- 6. The words "Archbishop-in-Council" shall be deemed to have in this Ordinance the same meaning as the same words in the "Sydney Church Ordinance 1912" or any Ordinance here-

after for the time being in force amending or taking the place of the same.

7. This Ordinance may be cited as the "Sydney Church of England Girls' Grammar School Amending Ordinance 1920."
