SYDNEY CHURCH OF ENGLAND GIRLS' GRAMMAR SCHOOL SALE ORDINANCE 1974

No. 43, 1974

AN ORDINANCE to authorise the sale of land vested in or held for the benefit of Sydney Church of England Girls' Grammar School Council.

WHEREAS Sydney Church of England Girls' Grammar School Council is a body corporate constituted by the Church of England (Bodies Corporate) Act 1938

AND WHEREAS various parcels of land are vested in the said body corporate in trust for the use benefit and purposes of the schools established or proposed to be established by the said body corporate AND WHEREAS moneys under the control of the said body corporate or borrowed by the said body corporate have been applied in acquiring other parcels of land but no trusts have been declared in relation to these parcels AND WHEREAS by reason of circumstances which have arisen subsequent to the creation of the said trusts it is expedient that all of the said parcels of land be sold NOW the Standing Committee of the Symod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-

- 1. (1) Where used herein, unless repugnant to the context or inconsistent therewith, the word "Council" means the said body corporate called Sydney Church of England Girls' Grammar School Council, and the term "S.C.E.G.G.S. land" means and includes
 - (a) the land described in the First Second Third Fourth and Fifth Schedules to the Sydney Church of England Girls' Grammar School Mortgage Ordinance 1954-1958,
 - (b) the land described in the Schedule to the Sydney Church of England Girls' Grammar School Mortgage Ordinance 1968,
 - (c) the land described in the Schedule to the Sydney Church of England Girls' Grammar School Mortgage Ordinance 1972, and
 - (d) the land described in the Schedule hereto.

- (2) This Ordinance may be cited as "Sydney Church of England Girls' Grammar School Sale Ordinance 1974".
- 2. By reason of circumstances which have arisen subsequent to the creation of the trusts on which the S.C.E.G.G.S. land is held, it is expedient that the S.C.E.G.G.S. land be sold.
- 3. (1) The Council is hereby authorised and empowered to sell the whole of the S.C.E.G.G.S. land in such parcels, at such time or times, in such manner, by such means, for such price or prices and on and subject to such terms and conditions as the Council, in its absolute discretion, may think fit.
- (2) Without limiting the generality of the authority and power conferred by sub-clause (1) of this clause, where any part of the S.C.E.G.G.S. land, in the opinion of the Council, could be used, by the purchaser thereof, as a school or college, the Council may require, as a condition of the sale thereof, that the purchaser thereof enter into a covenant with Church of England Property Trust Diocese of Sydney to the effect that the purchaser shall not represent or hold itself out, in connection with the S.C.E.G.G.S. land acquired by it or otherwise, as having any connection with the Church of England or any part or agency thereof whatsoever.
- 4. The Council shall apply the proceeds from the sale of the S.C.E.G.G.S. land in or towards meeting the debts of the Council, or any of them, as the Council shall think fit.
