An Ordinance to amend and consolidate the "Sydney Church of England Grammar School Council Mortgaging Ordinance 1952" as amended by "The Sydney Church of England Grammar School Council Mortgaging Ordinance 1925-1929" (No. 10, 1929) and to authorise Sydney Church of England Grammar School Council to mortgage certain real and personal property vested in the said Council.

WHEREAS pursuant to the provisions of an Act of the Legislature of New South Wales intituled "Saint James' School Compensation Trust Act" a school situate at North Sydney and known as Sydney Church of England Grammar School (hereinafter referred to as "the said School") was established in connection with the Church of England AND WHEREAS by the said Act it was enacted (inter alia) that the said School should be under the government of a Council consisting of such members of the Church of England as therein provided and the Bishop of Sydney for the time being should be ex officio President of such Council and that it should be lawful for the Synod of the Diocese of Sydney from time to time to make alter and repeal rules and regulations touching the constitution election and powers of the Council of the said School AND WHEREAS by the "Church of England Trust Property Act 1917" (Act No. 21, 1917) it was enacted that such persons as should from time to time be members of the said Council including the Archbishop of Sydney for the time being as ex officio President should be and they are thereby constituted a body politic and corporate by the name of "Sydney Church of England Grammar School Council" (hereinafter referred to as "the said Council") and that by such name they may take and hold to them their successors by grant will or otherwise any real or personal property and for any estate or interest therein AND WHEREAS by "The Sydney Church of England Grammar School Constitution Consolidation and Amendment Ordinance 1923" it was ordained and ruled (inter alia) that the said School should be governed by the said Council and that the said Council should manage and carry on the said School and its affairs and should govern and control the management and user of the Church Trust Property held in connection therewith in such manner as it may deem expedient for the benefit of the said

School AND WHEREAS by the "Sydney Church of England Grammar School Council Mortgaging Ordinance 1925" it was ordained and ruled that the said Council be and it was thereby authorised and empowered (inter alia) to mortgage certain real and personal property therein referred to to secure the repayment of advances not exceeding in the aggregate the sum of Fifteen Thousand Pounds (£15,000.0.0) AND WHEREAS by "The Sydney Church of England Grammar School Council Mortgaging Ordinance 1925-1929" it was ordained and ruled (inter alia) that the said limit of advances should be increased from Fifteen Thousand (£15,000.0.0) to Thirty Thousand (£30,000.0.0) and that the said Council be and it was thereby authorised and empowered to martgage certain other lands therein referred to AND WHEREAS the said Council is registered or entitled to be registered as the proprietor in fee simple under the provisions of the Real Property Act 1900 of the whole of the lands comprised and described in the First Schedule hereunder written AND WHEREAS the said Council is also seised of an estate in fee simple in those parcels of land comprised and described in the Second Schedule hereunder written AND WHEREAS the lands comprised and described in the First and Second Schedules hereunder are vested in the said Council upon trusts for the purposes of the said School AND WHEREAS by reason of circumstances subsequent to the creation of the said trusts it is expedient that the said Council should be empowered to mortgage the lands comprised and described in the first and second schedules hereunder written for the purpose of securing such sum or sums of money not exceeding in the aggregate at any one time the sum of Seventy-five Thousand Pounds (£75,000.0.0) (inclusive of the sums referred to in the hereinbefore recited Ordinances) as from time to time it may consider necessary to raise or borrow for carrying out all or any of the purposes hereinafter mentioned. Now therefore the Standing Committee of Synod of the Diocese of Sydney in the name and place of the said Synod ordains and rules as follows:

1. By reason of circumstances subsequent to the creation of the said recited trusts it is expedient and authority is hereby given for the said Council to mortgage the lands comprised and described in the first and second schedules hereunder written or any part or parts thereof for the purpose of securing such sum or sums of money not exceeding in the aggregate at any one time the sum of Seventy-five Thousand Pounds (£75,000.0).0) as from time to time it may consider necessary to raise or borrow for

carrying out all or any of the purposes hereinafter mentioned.

- 2. Any person company corporation or institution of any kind so advancing any such sum or sums may pay the same to the Treasurer for the time being of the said Council or such other person as the said Council may by resolution appoint for and on behalf of the said Council and the receipt of the said Treasurer or such other person so appointed as aforesaid shall be a full and sufficient discharge to such person company corporation or institution so advancing the same.
- 3. The amount or amounts from time to time so to be raised shall be applied by the said Council to the following purposes:—
 - (a) To pay the costs of and incidental to this Ordinance and of and incidental to any mortgage or mortgages executed by the said Council in pursuance thereof.
 - (b) To pay for any real or personal property that may be purchased by the said Council from time to time for the purposes of the said School.
 - (c) To pay for the erection of any new buildings upon any lands vested in the said Council from time to time or for remodelling adding to improving and for renovating any such buildings.
 - (d) To pay for any improvements that may be carried out by the said Council from time to time upon any lauds vested in the said Council, and/or
 - (e) Otherwise to pay or provide for the government conduct management and administration of the said School as the said Council may from time to time determine.
- 4. Any mortgages given by the said Council as aforesaid may be executed for and on behalf of the said Council by such person or persons being members of the said Council as the said Council may by resolution determine.
- 5. The "Sydney Church of England Grammar School Council Mortgaging Ordinance 1925" and "The Sydney Church of England Grammar School Council Mortgaging Ordinance 1925-1929" (No. 10, 1929), are hereby repealed but such repeal shall not affect any matter or thing done thereunder or pursuant thereto.

This Ordinance may be cited as the "Sydney Church of England Grammar School Council Mortgaging Ordinance 1953."
