AN ORDINANCE to authorise the mortgaging of all lands now held for the use benefit and purposes of the Sydney Church of England Grammar School for Girls, and for purposes incidental thereto.

WHEREAS the three several pieces of land described in the Schedule hereto are held in trust for the use benefit and purposes of the Sydney Church of England Grammar School for Girls and are subject to certain mortgages for securing the repayment of moneys which have been raised from time to time on the security of the said lands.

AND WHEREAS the land firstly described in the said Schedule is vested in the Sydney Church of England Girls' Grammar School Council being a body corporate (hereinafter called "the Council") and the lands secondly and thirdly described in the said Schedule are vested in the Most Reverend the Lord Archbishop of Sydney, though it is intended that the same shall shortly be vested in the Council.

AND WHEREAS it is expedient by reason of circumstances subsequent to the creation of the trusts of the said lands that such lands or any part thereof should be mortgaged from time to time in such manner and to raise or secure the repayment of such moneys as the Council shall determine and that the moneys so raised shall be applied for the use benefit and purposes of the said School in such manner as the Council shall direct.

Now the Standing Committee of the Synod of the Diocese of Sythey in the name and place of the said Synod declares directs unid ordains as follows:—

- 1. By reason of circumstances subsequent to the creation of the trusts to which the lands described in the Schedule hereto are subject it appears expedient that such lands should be mortgaged from time to time in such manner and to raise or secure the repayment of such moneys as the Council shall from time to time determine and accordingly such mortgaging is hereby directed.
- 2. The moneys so raised as aforesaid shall be applied for the use benefit and purposes of the said School in such manner as

the Council shall from time to time determine including the repayment of any moneys then secured upon the said lands or any part thereof and the payment of all costs charges and expenses of and incidental to this Ordinance and anything done in pursuance thereof.

3. This Ordinance may be cited as "The Sydney Church of England Grammar School for Girls Mortgage Ordinance 1948."

## THE SCHEDULE.

All that piece or parcel of land situated in the Municipality of North Sydney Parish of Willoughby and County of Cumberland being the whole of the land comprised in Certificate of Title Registered Volume 5201, Folio 236.

All that piece or parcel of land situated near Moss Vale in the Punicipality of Moss Vale Parish of Bong Bong and County of Camden being the whole of the land comprised in Certificate of Title Registered Volume 1962, Folio 235.

All that piece or parcel of land situated in the City of Sydney Parish of Alexandria and County of Cumberland being the whole of the land comprised in Certificate of Title Registered Volume 2100, Folio 214.
