
*Sydney Church of England Homes for Aged Persons
Board of Management Incorporation Ordinance, 1961.*

No. 53, 1961.

AN ORDINANCE to authorise the incorporation of the Board of Management of "Sydney Church of England Homes for Aged Persons" as a body corporate pursuant to the provisions of the Church of England (Bodies Corporate) Act 1938.

WHEREAS by "Sydney Church of England Homes for Aged Persons Constitution Ordinance 1961" the Standing Committee of the Synod of the Diocese of Sydney constituted "Sydney Church of England Homes for Aged Persons" and provided for a Board of persons for the management and control of its affairs AND WHEREAS the Church of England (Bodies Corporate) Act 1938 was assented to on the 26th October 1938 AND WHEREAS by the "Church of England (Bodies Corporate) Act 1938 Delegation of Powers Ordinance 1961" the Synod of the Diocese of Sydney appointed the Standing Committee of such Synod as the Committee to exercise from time to time during the recess of such Synod certain powers authorities duties and functions of Synod conferred upon it by the said Act including the constitution of a body corporate in pursuance of the provisions of Section 4 of the said Act AND WHEREAS it is expedient that the Board of Management of Sydney Church of England Homes for Aged Persons as constituted by Sydney Church of England Homes for Aged Persons Constitution Ordinance 1961" should be constituted a body corporate as provided by the said Act NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ORDAINS DIRECTS AND RULES as follows:-

1. The Standing Committee of the Synod of the Diocese of Sydney hereby declares that it is expedient for the purpose of managing governing and controlling the institution or organisation of the Church of England in the Diocese of Sydney known as "Sydney Church of England Homes for Aged Persons" that the persons who for the time being are members of the Board of Management of Sydney Church of England Homes for Aged Persons should be constituted a body corporate under the name of "Board of the Sydney Church of England Homes for Aged Persons."

2. This Ordinance may be cited as "Sydney Church of England Homes for Aged Persons Board of Management Incorporation Ordinance 1961."
