## SYDNEY CHURCH OF ENGLAND NEW AREAS COMMITTEE CONSTITUTION AMENDMENT ORDINANCE 1978

## No. 14 1978

AN ORDINANCE to amend the constitution of the Sydney Church of England New Areas Committee.

## WHEREAS

- A. It is expedient to amend the provisions of the Sydney Church of England New Areas Committee Constitution Ordinance 1967 (hereinafter called the "Principal Ordinance") in certain respects.
- B. The Sydney Church of England New Areas Committee manages real and personal property which is church trust property within the meaning of the Church of England Trust Property Act 1917 as amended.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-

- 1. (1) This Ordinance may be cited as "Sydney Church of England New Areas Committee Constitution Amendment Ordinance 1978".
- (2) The Principal Ordinance as amended by this Ordinance may be cited as "Sydney Church of England New Areas Committee Constitution Ordinance 1967-1978" and in any reprint of that Ordinance clause 1 shall be amended accordingly.
- 2. The Principal Ordinance is amended by:-

- (a) Adding the following after the word "areas" in item (ii) of clause 4(e):-
  - "and in or towards the stipend accommodation and expenses of the Director of New Areas".
- (b) Deleting all of the words in item (iii) of clause 5(a) and inserting the following:-

"The Director of New Areas (ex officio)".

(c) Adding the following new sentence at the commencement of clause 6:"The Director of New Areas shall be appointed and his
stipend and conditions determined by the Archbishop
in consultation with the Committee. His appointment
may be terminated by the Committee with the approval of

- 3. The Principal Ordinance is further amended by adding the following new item after item (v) in clause 4(e):-
  - "(vi) To make grants at its discretion to parishes for specific assistance for ministry in new housing areas within such parishes."
- 4. Clause 5(a) of the Principal Ordinance is amended by deleting "being members of Synod" from paragraph (iv) and "all being members of Synod" from paragraph (v).
- 5. Clause 7 of the Principal Ordinance is amended by deleting "from the lst April (or date of its constitution) to 31st March next following" and inserting the following:-

"determined in accordance with the provisions of the Accounts
Ordinance 1975 as amended".
