SYDNEY CHURCH ORDINANCE SUBSTANTIAL REPEAL ORDINANCE 1990

No. 39, 1990

AN ORDINANCE to repeal many of the provision of the Sydney Church.

WHEREAS in view of the Church Grounds and Eulldings Ordinance 1990 and the Church Administration Ordinance 1990 it is expedient to repeal many of the provisions of the Sydney Church Ordinance 1912.

NOW the Synod of the Diocese of Sydney hereby ordains as follows --

Citation

- 1. (1) This Ordinance may be cited as the "Sydney Church Ordinance (Substantial Repeat) Ordinance 1990".
- (2) The Sydney Church Ordinance 1912 is in this Ordinance referred to as the "Principal Ordinance".

a Repeal, amendment and savings

- 2. (1) The Principal Ordinance, except for Section 1, Sections 4, 5, and 9 and Sections 25, 26, 27 and 28 in Part 7;—Glebe Lands, is repealed.
- (2) Section 1 of the Principal Ordinance is omitted and the following
 - 1. This Ordinance may be cited as the Trustees and Glebo Lands Ordinance 1912.
 - (3) Section 9 of the Principal Ordinance is amended by the insertion of the words "(other than the Property Trust)" after the words "Parochial Church Property".
 - (4) The repeat of the Principal Ordinance does not affect or invalidate any act done or appointment or election made under that Ordinance and all persons appointed or elected under that Ordinance and holding office on the date of commencement of this Ordinance remain in office as if they had been elected or appointed under the Church Administration Ordinance 1990, the Church Grounds and Buildings Ordinance 1990 or the Trustees and Glebe Lands Ordinance 1912, as the case requires.
 - (5) Anything commenced to be done under the Principal Ordinance may be continued under the Church Administration Ordinance 1990, the Church Grounds and Buildings Ordinance 1990 or the Trustees and Glebe Lands Ordinance 1912, as the case requires, as if it had been commenced under the Church Administration Ordinance 1990, the Church Grounds and Buildings Ordinance 1990 or the Trustees and Glebe Lands Ordinance 1912 as the case requires.
 - (6) A reference in any other ordinance to the Sydney Church Ordinance 1912 or to a provision of that Ordinance is to be read and

considered as if it were a reference to the Church Administration Ordinance 1990, the Church Grounds and Buildings Ordinance 1990 on the Trustees and Glebe Lands Ordinance 1912, as the case requires of the Church Administration Ordinance 1990 or the Church Grounds and Buildings Ordinance 1990 or the Trustees and Glebe Lands Ordinance 1912, as the case requires.

Commancement

- 3. (1) This Ordinance commences on a day to be determined by the Archbishop-in-Council.
- (2) The Diocesan Secretary is to notify the minister of each parish and the churchwardens of each church of the date so determined.
