AN ORDINANCE to vest certain property and to very the trusts on which certain property is held.

WHEREAS

- A. The moneys specified in part 1 of the achedules and the investments representing the same are believed to be church trust property held upon a trust for the Church of England in Australia in the Diocese of Sydney.

 B. The moneys specified in part 2 of the achedules are believed to be income from the moneys described in part 1 of the schedule which has not
- <u>C.</u> The name attributed to the trust on which moneys described in part 1 and part 2 of a schedule is held is that mentioned in part 3 of the schedule.

 <u>D.</u> The particular trust on which the moneys specified in part 1 and part 2 of a schedule is held (where known) is believed to be the trust described in part 4 of the schedule.
- E. The trustee of some of the moneys specified in the schedule (and any investments representing the same) is the Archbishop of Sydney but in other instances the trustee is not known.
- <u>F.</u> It is expedient that certain of the moneys specified in the schedules (and the investments representing the same) be vested in Church of England Property Trust Diocese of Sydney.
- G. By reason of circumstances which have arisen subsequent to the creation of the trusts on which moneys specified in part 1 and part 2 of the schedules (and any investments representing the same) are held it is impossible or inexpedient to carry out the same NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod MEREBY DRDAINS DECLARES DIRECTS AND RULES as follows:-
- 1. The moneys specified in part 1 and part 2 of the third, fourth, fifth and seventh schedules (and any investments representing the same) are hereby vested in Church of England Property Trust Diocese of Sydney.
- 2. (1) By reason of circumstances which have arisen subsequent to the creation of the trusts on which the moneys specified in part 1 and part 2 of the schedules(and any investments representing the same) are held it is impossible or inexpedient to carry out the same to the extent that

the same, are hereby varied.

- (2) The moneys specified in part 1 and part 2 of each of the first, second, sixth and eight to nineteenth schedules inclusive(and any investments representing the same or the process from the realisation of any such investments) shall be held upon trust to permit the same to be paid (or transferred) to the person described in part 5 of that schedule and to be held or applied for the purpose described or referred to in part 6 of that schedule.
- (3) The moneys specified in part 1 and part 2 of the third, fourth and fifth schedules (and any investments representing the same) shall be amalgamated and the annual income therefrom applied as follows:-

As to fifteen percentum (15%) thereof the same shall be capitalised; as to ten percentum (10%) thereof the same shall be paid to the Wollongong Diocese Endowment Fund; as to twenty five percentum (25%) thereof to the Rector for the time being of the Parish of St. Simon and St. Jude, Bowral and as to the balance to the churchwardens, from time to time, of the church known as St. Simon and St. Jude Bowral to be applied towards the cost of maintenance and restoration of the Church, Church Halls and Rectory in the Parish of Bowral and of the furniture and furnishings contained therein.

- (4) The moneys specified in part 1 and part 2 of the seventh schedule shall be held upon the trust set forth in part 5 of that schedule.
- (5) All income from the moneys specified in all of the schedules (or any investments representing the same) shall be deemed to have been held upon a trust which permitted such income to be applied in the manner in which the same has been actually applied.
- (6) Any income from the moneys specified in any of the schedules (or any investments representing the same) prior to the same being dealt with in the manner provided in this ordinance shall be dealt with as if the same is part of those moneys.
- 3. This ordinance may be cited as "Sydney Diocesan Account Ordinance 1977".
