2nd Summary of appropriations and allocations for 2000 to 2002

An Ordinance to authorise financial appropriations and allocations for 2001 and for incidental matters.

Whereas -

A. By the Synod Estimates Ordinance 1999 (the "1999 Ordinance"), the Synod of the Diocese of Sydney adopted certain financial estimates for 2001 and stated its intentions for certain financial appropriations and allocations for 2001.

B. By clause 6 of the 1999 Ordinance, the Standing Committee may apply allocations referred to in that ordinance for other purposes, in the circumstances set out in that clause.

C. It is expedient to implement the Synod's intentions for financial appropriations and allocations for 2001 on the terms set out in this Ordinance.

The Standing Committee of the Synod of the Diocese of Sydney ordains -

1. Name

This Ordinance is the Synod Appropriations and Allocations Ordinance 2000.

2. Declarations

(1) By reason of circumstances that have arisen after the creation of the trusts of each of the amounts referred to in the column headed "2001 Proposed" in the 1st Schedule, it is inexpedient to carry out and observe those trusts

or to apply those amounts solely for the same or like purposes as the trusts on which those amounts are presently held.

(2) Under clause 6 of the 1999 Ordinance, the Standing Committee declares that the full amount of certain allocations referred to in that clause which were intended to be made in 2001 are not required, or cannot be applied, for the purposes for which those allocations were intended.

3. Appropriations and allocations for 2001

- (1) The Standing Committee directs that -
- (a) the amount referred to alongside the matter "Diocesan Endowment Ordinance 1984" in the column headed "2001 Proposed" in the 1st Schedule be paid by the Glebe Administration Board to the Standing Committee during 2001 under clause 4 of the Diocesan Endowment Ordinance 1984; and
- (b) the amount so paid is to be applied by the Standing Committee towards the allocations in the column in the 2nd Schedule headed "2001", in the manner further particularised in the line item schedules which formed part of the explanatory statement for this Ordinance.
- (2) Subject to clause 4, the Standing Committee directs that the other amounts referred to in the column headed "2001 Proposed" in the 1st Schedule also be applied towards the allocations in the column in the 2nd Schedule headed "2001", in the manner further particularised in the line item schedules forming part of the explanatory statement for this Ordinance.

4. Creation of provision

The Standing Committee directs that any balance remaining as at 31 December 2000 of the allocation of \$811,000 made in 2000 to the Archbishop-in-Council for Diocesan Projects (including churches, schools, new sites and Moore College), such allocation forming part of the grant for Capital Projects in Line Item 13 of the 2nd Schedule to the 1999 Ordinance, be transferred to a reserve to be applied by the Archbishop-in-Council for such projects in a future year.

5. Non-application of other ordinances

- (1) The Standing Committee is not required to make a recommendation to the Synod in 2000 under clause 4(2) of the Diocesan Endowment Ordinance 1984
- (2) The Standing Committee is not required to bring a proposed ordinance to the Synod under clause 4(1) of the Synod Estimates Ordinance 1998 for the allocations in the column in the 2nd Schedule headed "2001".
