

Synod Appropriations and Allocations Ordinance 2016

No 55, 2016

Long Title

An Ordinance to authorise financial appropriations and allocations for 2017 and for incidental matters.

Preamble

A. By clause 6(1) of the Synod Appropriations and Allocations Ordinance 2015 (the "2015 Ordinance") the Synod stated its intentions for certain financial appropriations and allocations for 2017 and by clause 6(2) directed that the Standing Committee pass all such ordinances as may be necessary from time to time to give effect to such intentions.

B. The total amount available to be appropriated from the Diocesan Endowment and certain other trusts in 2017 is more than the total amount estimated under the 2015 Ordinance.

C. It is expedient to increase the amount allocated by the Synod in 2017 to the extent of the additional funds available.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name

This Ordinance is the Synod Appropriations and Allocations Ordinance 2016.

2. Declaration

By reason of circumstances which have arisen after the creation of the trusts on which the amounts referred to in the column headed "Estimate for 2017 – Synod Appro. & Alloc. Ord." in the "SOURCE OF FUNDS" section of Attachment 1 to the Standing Committee's Explanatory Report about the 2015 Ordinance are held, it is inexpedient to carry out or observe those trusts or to apply those amounts solely for the same or like purposes as those trusts.

3. Variation of trusts

The trusts referred to in clause 2 are varied to such extent as is necessary to permit the directions referred to in clause 4.

4. Appropriations and allocation for 2017

(1) The Standing Committee directs that the amounts referred to in the column headed "Standing Committee's proposal for 2017 – Synod Appro. & Alloc. Ord." in the "SOURCE OF FUNDS" section of the Attachment to the Report of the Ordinance Reviewer about this Ordinance be appropriated in the manner specified in that column in lieu of the amounts specified to be appropriated in the column headed "Estimate for 2017 – Synod Appro. & Alloc. Ord." in the "SOURCE OF FUNDS" section of Attachment 1 to Standing Committee's Explanatory Report to the Synod about the 2015 Ordinance.

(2) The Standing Committee directs that the amounts referred to in the column headed "Standing Committee's proposal for 2017 – Synod Appro. & Alloc. Ord." in the "USE OF FUNDS" section of the Attachment to the Report of the Ordinance Reviewer about this Ordinance be allocated in the manner specified in that column in lieu of the amounts specified to be allocated in the column headed "Estimate for 2017 – Synod Appro. & Alloc. Ord." in the "USE OF FUNDS" section of Attachment 1 to the Standing Committee's Explanatory Report to the Synod about the 2015 Ordinance.
