

Synod Appropriations and Allocations Ordinance 2020

No 57, 2020

Long Title

An Ordinance to authorise financial appropriations and allocations for 2021 and for incidental matters.

Preamble

A. By clause 6(1) of the *Synod Appropriations and Allocations Ordinance 2018* (the “2018 Ordinance”) the Synod stated its intentions for certain financial appropriations and allocations for 2021 and by clause 6(2) directed that the Standing Committee pass all such ordinances as may be necessary from time to time to give effect to such intentions.

B. The total amount available to be appropriated from the Diocesan Endowment and certain other trusts in 2021 is slightly more than the total amount estimated under the *2018 Ordinance*.

C. It is expedient to increase the amount allocated by the Synod in 2021 to the extent of the additional funds available.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name

This Ordinance is the Synod Appropriations and Allocations Ordinance 2020.

2. Declaration

By reason of circumstances which have arisen after the creation of the trusts on which the amounts referred to in the column “Estimate for 2021 – Synod Appro. & Alloc. Ord.” in the “SOURCE OF FUNDS” section of Attachment 1 to the Standing Committee’s Explanatory Report about the 2018 Ordinance are held, it is inexpedient to carry out or observe those trusts or to apply those amounts solely for the same or like purposes as those trusts.

3. Variation of trusts

The trusts referred to in clause 2 are varied to such extent as is necessary to permit the directions referred to in clause 4.

4. Appropriations and allocations for 2020

(1) The Standing Committee directs that the amounts referred to in the column “DRC/Standing Committee proposal for 2021 – Synod Appro. & Alloc. Ord.” in the “SOURCE OF FUNDS” section of the Attachment to the Report of the Ordinance Reviewer about this Ordinance be appropriated in the manner specified in that column instead of the manner specified in the column “Estimate for 2021 – Synod Appro. & Alloc. Ord.” in the “SOURCE OF FUNDS” section of Attachment 1 to Standing Committee’s Explanatory Report to the Synod about the 2018 Ordinance.

(2) The Standing Committee directs that the amounts referred to in the column “DRC/Standing Committee proposal for 2021 – Synod Appro. & Alloc. Ord.” in the “USE OF FUNDS” section of the Attachment to the Report of the Ordinance Reviewer about this Ordinance be allocated in the manner specified in that column instead of the manner specified in the column “Estimate for 2021 – Synod Appro. & Alloc. Ord.” in the “USE OF FUNDS” section of Attachment 1 to the Standing Committee’s Explanatory Report to the Synod about the 2018 Ordinance.
