# Synod Estimates and Parochial Cost Recoveries (Transition) Ordinance 2012

No 8, 2012

# **Long Title**

An Ordinance to provide transitional arrangement for the preparation of ordinances for Synod estimates and parochial cost recoveries.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

#### 1. Name

This Ordinance is the Synod Estimates and Parochial Cost Recoveries (Transition) Ordinance 2012.

# 2. Synod Estimates

The Synod Estimates Ordinance 1998 is amended as follows -

- (a) insert the following new clauses 3(1) and (2) (with consequential renumbering of existing subclauses)
  - "(1) The Standing Committee must prepare for the second ordinary session of the 49<sup>th</sup> Synod a statement of funding principles and priorities and a proposed ordinance reflecting that statement which contains estimates for the following financial year of the matters specified in subclause (4).
  - (2) The Standing Committee must prepare for the third ordinary session of the 49<sup>th</sup> Synod a proposed ordinance reflecting the statement referred to in subclause (1) which contains estimates for the following two financial years of the matters specified in subclause (4).", and
- (b) in renumbered clause 3(3) -
  - (i) delete the matter "second ordinary session of the 48<sup>th</sup>" and insert instead the words "first ordinary session of the 50<sup>th</sup>", and
  - (ii) delete the matter "subclause 2" and insert instead the matter "subclause (4)",
- (c) in renumbered clause 3(4) delete the matter "48th" and insert instead the matter "50<sup>th</sup>", and
- (d) delete renumbered clause 3(5) and insert instead the following
  - "(5) A proposed ordinance prepared under subclause (4) for consideration at the second ordinary session of a Synod is to reflect the statement of funding principles and priorities prepared under subclause (3)."

# 3. Parochial Cost Recoveries

The Cost Recoveries Framework Ordinance 2008 is amended as follows -

- (a) insert new clauses 5(1) and (2) as follows (with renumbering of existing subclauses)
  - "(1) The Standing Committee must prepare for the second ordinary session of the 49<sup>th</sup> Synod a proposed ordinance for adoption by the Synod which
    - specifies the cost recoveries charge in respect of ministry costs and parochial network costs to be paid by each parish in the following financial year, and
    - (b) authorises Standing Committee to apply the cost recoveries charges paid by parishes in that financial year towards ministry costs and parochial network costs.

# Synod Estimates and Parochial Cost Recoveries (Transition) Ordinance 2012

- (2) The Standing Committee must prepare for the third ordinary session of the  $49^{\rm th}$  Synod a proposed ordinance for adoption by the Synod which
  - (a) specifies the cost recoveries charge in respect of ministry costs and parochial network costs to be paid by each parish in the following two financial years, and
  - (b) authorises Standing Committee to apply the cost recoveries charges paid by parishes in a financial year towards ministry costs and parochial network costs."
- (b) in renumbered clause 5(3) delete the matter "48th" and insert instead the matter " $50^{th}$ ".
