

West Lindfield (ACPT Client Fund 0716) Variation of Trusts Ordinance 2020

No 51, 2020

Long Title

An Ordinance to vary the trusts of certain funds held under the *West Lindfield Trust Ordinance 2019*.

Preamble

A. The Anglican Church Property Trust Diocese of Sydney is the trustee of the ACPT – West Lindfield Trust held under the *West Lindfield Trust Ordinance 2019*.

B. By clause 5 of *West Lindfield Trust Ordinance 2019*, the ACPT – West Lindfield Trust is held on trust for the purposes of the Parish of West Lindfield (the “Parish”), subject to the terms of that Ordinance.

C. The ACPT – West Lindfield Trust is comprised, in part, of ACPT Client Fund 0716 which arises from certain funds that were held in the Glebe Income Accounts for the Parish and later transferred to the ACPT.

D. By reason of circumstances which have arisen after the creation of the trusts on which that part of the ACPT – West Lindfield Trust comprising ACPT Client Fund 0716 is held, it is inexpedient to carry out and observe those trusts and it is expedient to vary those trusts in the manner set out in this Ordinance.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name

This Ordinance is the West Lindfield (ACPT Client Fund 0716) Variation of Trusts Ordinance 2020.

2. Declarations

By reason of circumstances which have arisen after the creation of the trusts on which that part of the ACPT – West Lindfield Trust comprising ACPT Client Fund 0716 is held, it is inexpedient to carry out or observe those trusts and it is expedient that those trusts be varied in the manner set out in clause 3.

3. Variation of Trusts

The trusts of that part of the ACPT – West Lindfield Trust comprising ACPT Client Fund 0716 are varied to the extent necessary to permit the payment in clause 4.

4. Application

The ACPT is authorised to pay the current balance of ACPT Client Fund 0716 as at the date of assent to this Ordinance to the Wardens of All Saints’ Air Force Memorial Church West Lindfield to be applied for such purposes of the Parish as may be determined from time to time by resolution of the Parish Council of the Parish.
