



William Branwhite Clarke College Ordinance 1987 Amendment Ordinance 1996

Long Title

An Ordinance to amend the William Branwhite Clarke Ordinance 1987.

Preamble

Whereas it is expedient to amend the William Branwhite Clarke College Ordinance 1987 (the "Principal Ordinance").

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows -

Name of Ordinance

1. This ordinance is the William Branwhite Clarke College Ordinance 1987 Amendment Ordinance 1996.

Amendment of the Principal Ordinance

2. The Principal Ordinance is amended as follows -

(a) subclause 2(f) is deleted and the following is inserted instead -

"(f) 'Episcopal Region' means that Region of the Diocese in which the Bishop of Parramatta exercises episcopal authority from time to time.";

(b) subclause 2(g) is deleted and the following is inserted instead -

"(g) 'Principal' means the head or teacher in charge of the School.";

(c) subclause 2(k) is deleted and the following is inserted instead -

"(k) 'Regional Council' means the Parramatta Regional Council as constituted under the Regions Ordinance 1995.";

(d) in clauses 3(c) and 3(d) the matter "Hills Region" is deleted and the matter "Episcopal Region" is inserted instead.

(e) clause 8(1)(d) is deleted and the following is inserted instead -

"(d) becomes an insolvent under administration;"

(f) clause 9 is deleted and the following is inserted instead -

"9. The Archbishop shall be the President of the Council. The Bishop of Parramatta shall be the Deputy President."

(g) clause 10 is deleted and the following is inserted instead -

"10. (1) Subject to clause 10(2), the Chairman shall be elected by members of the Council from one of their members for a period of one year, and shall preside at each meeting;

(2) Should the President or Deputy President attend a meeting of Council, then the President or Deputy President may elect to preside at the meeting.

(3) The person presiding at a meeting shall have both a deliberative vote and a casting vote at that meeting.";

(h) in clause 11 -

(i) the matter "(1)" is deleted; and

(ii) subclause 11(2) is deleted; and

(i) the schedule is deleted.

Transitional

3. The amendment in clause 2(c) commences on the date on which the Regions Ordinance 1995 commences. All other provisions of this Ordinance commence on the date this Ordinance receives assent.
