*Wongawilli Exchange Ordinance of 1943.*

No. 2, 1943.

AN ORDINANCE to authorise the exchange of land situated in the Parish of Kembla County of Camden comprised in Certificate of Title Registered Volume 4183 Folio 104 for the land situated in the same Parish and County and being Lot 3 in Deposited Plan 18020 and being part of the land comprised in Certificate of Title Registered Volume 4426 Folio 153.

WHEREAS by instrument of Transfer No. 649016 the land comprised in the said Certificate of Title Registered Volume 4183 Folio 104 was transferred by way of gift to the Church of England Property Trust Diocese of Sydney (hereinafter called the Trust) by Australian Iron and Steel Limited of 58 Margaret Street Sydney (hereinafter called the Company). AND WHEREAS by Declaration of Trust dated the Eighth day of November 1928 the Trust declared that the lastly referred to land was held upon trust to permit the same to be used for a Church Parsonage or Parish Hall or partly for one and partly for another or others of such purposes in connection with the Church of England in the Parish of Dapto. AND WHEREAS a Church Hall was built thereon. AND WHEREAS by arrangement with the Trust the said Church Hall was subsequently transferred by the Company to the said Lot 3 but no exchange of the respective pieces of land was made. AND WHEREAS by reason of circumstances subsequent to the creation of the said Trust it is expedient to exchange the said respective pieces of land. Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the Synod of the said Diocese, ordains and declares.

1. It is expedient to exchange the said land comprised in Certificate of Title Registered Volume 4183 Folio 104 freed and discharged from the hereinbefore recited trusts for the said land described as Lot 3 on the Deposited Plan No. 18020 and to transfer the said land comprised in Certificate of Title Registered Volume 4183 Folio 104 to the Company.

2. The said Trust is hereby directed to execute the transfer or transfers or other instrument or instruments and to do all acts measures and things necessary for the purpose of carrying into effect the said exchange.

3. The Synod hereby declares that the said land described as Lot 3 in Deposited Plan No. 18020 shall when transferred be held upon trust to permit the same to be used for a Church Parsonage or Parish Hall or partly for one and partly for another or others of such purposes in connection with the Church of England in the Parish of Dapto with Albion Park.

4. This Ordinance shall be called the "Wongawilli Exchange Ordinance of 1943."
